#### **Important Dates**

March 1, 2005 – Any monies raised prior to this date will not count towards the seed money requirement to accept Public Campaign Finance Funds for the Gubernatorial Election.

**July 5, 2005** – First day candidates can file for candidacy for the 2006 election

August 5, 2005 – Due
Date for the semi-annual
Contribution Disclosure
Form (Only for corporations
who have made
contributions and/or
employ lobbyists)

**July 3, 2006** – Deadline to file for candidacy for the 2006 election.

## Important Notice to Treasurers and Chairmen

As the campaign season rapidly approaches, many new campaign finance entities will be established. Before becoming a Responsible Officer for a campaign entity, it is imperative that you know the law regarding your duties, responsibilities and liabilities. This notice is intended to serve as a brief guide. It is highly recommended that you consult the relevant statutes and attend the classes.

To serve as a Chairman or Treasurer an individual must be:

- a registered voter of the State of Maryland
- in good standing with the Candidacy and Campaign Finance Division.

The Responsible Officers are not required to live in the same district as the candidate or have the same party affiliation. It is permissible for an officer to

serve on more than one committee. A candidate cannot serve as the Treasurer for his/her own committee.

Generally, the Treasurer is responsible for the receipt and expenditure of campaign funds for political purposes. All assets received by or on behalf of the campaign finance entity must be delivered to and maintained by the Treasurer. Only the Treasurer can disburse or expend campaign funds. In addition, the Treasurer's signature is required on all campaign finance reports. Maryland law also requires that the Treasurer keep a detailed and accurate account book on behalf of the campaign finance entity. The account books must be preserved for 2 years after the campaign finance entity files a final campaign finance report.

The ultimate responsibility for compliance with the campaign finance law rests

Treasurer may not serve "in name only" and may not delegate any statutory responsibility to another person including the candidate, except to a duly appointed sub-Treasurer. There are no statutory provisions permitting "assistant treasurers." While the Chairman is not assigned any specific duties under the law, the Chairman also bears responsibility for filing timely reports. The committee officers together are jointly and severally responsible for filing all campaign reports. An officer who resigns is still liable for any outstanding reports or late fees incurred during the tenure of the officer. Thus, an officer may be responsible for a report following the resignation, if the resignation was received in the middle of a reporting period. To update your current Electrack software with 2006 reporting dates, you must download the patch from www.electionsmaryland.com under the New Campaign Finance Patch link or contact SBE at 410-269-2880 and request the patch be mailed to you on diskette.

### Public Financing for Gubernatorial Candidates

For a gubernatorial ticket to qualify to receive public funds, the candidate must raise the required seed money. The seed money must be received after March 1, 2005 and in increments of \$250 or less from individual contributors. If the contribution is greater than \$250, the amount over \$250 is disregarded for seed

money calculations. The amount of seed money needed will be announced after January 1, 2006.

## Frequently Asked Questions

#### Can a candidate join a slate committee without having a candidate committee?

No, candidates must have their own campaign finance entity established prior to joining a slate committee.

# Are candidates still members of a slate after the election?

Yes, once a candidate joins a slate committee, the candidate is a member until he/she withdraws or resigns or the slate committee is closed.

# What is required to open a campaign depository account at abank?

Most banks will require a Form SS-4 (Application for Employer Identification Number), personal identification and a Resolution of Authority.

#### What documents satisfy the Resolution of Authority requested by banks to open a depository account?

A bank should accept the processed Statement of Organization for a newly formed committee by the SBE to open a depository account.

# If I send in a new appointment for a Treasurer and/or Chairman, do I immediately replace the previous officer?

No, the previous officer must resign in writing prior to the appointment of any new officer.

#### I have a State compaign finance entity but want to run for U.S. Congress, can I transfer over the monies to my federal compaign entity?

Generally, Maryland campaign funds are for State candidates. However, it is permissible for a State campaign finance entity to make expenditures to support a federal candidate or federal PAC. In order to make a contribution, the entity's account must have federally permissible funds equaling the contribution. Please contact the Federal Election Commission to find out what are the contribution limits and reporting requirements, if any.

# Are therelimits to cosh contributions?

Yes, a person may make cash contributions up to \$100 for an election cycle. Once the person contributes \$100, the person can no longer make any cash contributions for the

remainder of the election cycle.

# What happens if there is a vacancy with either my chairman or treasurer?

If you are missing an officer you may not have any financial activity until a new officer is appointed. It is very important for a campaign finance entity fill any vacancy either by resignation or death immediately.

#### My central committee appointed me Treasurer, do I notify SBE?

Yes, if your party central committee voted a new officer, the new officer has to send in the appointment form to SBE and the previous officer needs to send SBE a resignation letter.

#### Are compaign treasurers required to keep a copy of receipts issued for compaign contributions?

It is not required for treasurers to keep copies of contribution receipts. The only receipt that the law requires treasurer to keep as part of the treasurer's books and records is the receipt from a campaign expenditure.

#### Records Management

The treasurer must keep a detailed and accurate account book for all the financial activity of the campaign finance entity. This includes contributions and transfers received. expenditures made and any and all obligations incurred by the campaign finance entity. The retention of the records may be in a electronic format, i.e. scanned or in a hard copy. If the entity stores campaign finance reports as a pdf, the reports are to be scanned and cannot be altered.



#### Campaign Software

SBE provides free software (ELECTrack EFS) for your use to file campaign finance reports. However, the law does not require you to use the SBE's software. ELECTrack EFS is not a comprehensive campaign management system and doesn't interface with other programs, such as check writing or accounting software.

If you want a campaign management system, you may consider using software from a private vendor. But you should be aware that the private vendor's software must be compatible with SBE's ELECTrack database.

## **Exploratory Committees**

Maryland does not recognize the existence of an exploratory committee. It is highly recommended that the potential candidate establish a campaign finance entity. Establishment of the campaign finance entity does not require the potential candidate to file a certificate of candidacy. The potential candidate may raise funds and make expenditures out of this account and then if he or she decides to run for office may use this campaign finance entity as the candidate's committee.

However, if a potential candidate decides not to establish a campaign finance entity and wants to "Test the Waters," the potential candidate is not required to file a campaign finance report for any expenditures made. However, by not establishing a campaign finance entity any monies used would be prohibited for actual campaign activities. Exploratory funds can only be used for legitmate exploratory activites. Additionally, any monies in the exploratory committee's

account can only contribute \$4000 to the authorized campaign finance entity of the candidate.

It is important to note that certain activities regardless of the reporting requirement fall within the purview of the campaign finance regulations. For example, a potential candidate sends out personal letters to would be voters while not soliciting but indicating his/her interest in running for office would require an authority line indicating the candidate's name and address

## How to Become a Candidate for Office

Before appearing on the ballot for elective office, candidates are required to establish a campaign finance entity. Once the campaign finance entity is established, then a candidate may file for office.

At the time of filing, a candidate must complete a Certificate of Candidacy and a Financial Disclosure Statement. In addition, a filing fee and photo identification are required.

The deadline for being on the 2006 ballot is July 3, 2006. All filings are required to be in-person at the appropriate board of election.
