

**ANNAPOLIS (May 26, 2022) –** The Maryland State Board of Elections is encouraging eligible voters interested in casting a ballot in July's primary election to <u>register to vote online</u>. SBE is also urging those who are already registered to confirm their latest district and polling place information using the <u>online voter lookup tool</u>.

The deadline to register to vote in the 2022 Primary Election is Tuesday, June 28. Those using the online registration system must submit their completed voter registration application by 11:59 p.m. on that date. To ensure applications are completed and received by 11:59 p.m., SBE advises voters to access the online system no later than 11:50 p.m. on June 28. Those who prefer not to register to vote online may print the registration form (English version and Spanish version) and return it by mail or do so at the office of their local board of elections by 5 p.m. on June 28.

Following the recent redistricting process, county district, state legislative district and congressional district information – as well as polling place information – for some registered voters has changed. For this reason, it is important that all registered voters confirm their current district and polling place information online or by calling or visiting the office of their local board of elections.

"This week, we launched a statewide digital advertising campaign to educate Maryland voters on the registration deadlines and to encourage those who intend to cast a ballot in this year's primary election to ensure they have the latest district and polling place information," said Maryland State Board of Elections Administrator Linda H. Lamone. "As in previous years, there will be three ways for eligible Marylanders to cast their ballots – by mail, secure dropbox or in person. But the process for every voter should begin today, either by registering or confirming they have the latest information about their districts and polling places."

On May 20, the members of the State Board of Elections finalized the list of all early voting, drop-box and election day polling locations. Election day polling locations are available via the online lookup tool.

## **DECLARATION OF QUORUM PRESENT**

Mr. Voelp called the meeting to order at 2:02 pm and declared that a quorum was present.

#### ADDITIONS TO THE AGENDA

There were no additions to the agenda.

## APPROVAL OF MEETING MINUTES: MARCH 10, 2022

Mr. Miller made a motion to approve the minutes from the March 10, 2022 open and closed meetings. Mr. Williams seconded the motion. The motion passed unanimously.

### ADMINISTRATOR'S REPORT

Mr. Voelp requested that only highlights of the Administrator's Report be presented verbally.

#### ANNOUNCEMENTS & IMPORTANT MEETINGS

## **U.S. Election Assistance Commission's Standards Board Meeting**

On April 14, the U.S. Election Assistance Commission's (EAC) Standards Board met virtually for its annual meeting. The Standards Board has two election officials - one State official and one local election official - from each State. Ms. Charlson and Guy Mickley, Election Director for the Howard County Board of Elections, are Maryland's representatives on the Standards Board. During this meeting, the members received an update from the work of the EAC, implementation of the Voluntary Voting System Guidelines 2.0, a discussion about supply chain issues and the impact on election materials (including ballot paper), and Ohio's proposed voter registration certification program.

## **Election Directors' Meeting**

In response to the work required to implement the new Congressional and legislative redistricting plans, we hosted weekly election directors' meetings in March and April. Other

election-related information was shared during these calls, but most of the discussion related to redistricting. Meeting summaries will be distributed via the County Bulletin when finalized.

## **Redistricting Updates**

Ms. Charlson reported that boundaries for <u>Congressional districts</u>, <u>legislative districts</u>, and county districts are now final, and the local boards of elections are updating the voter registration database to place voters into their new districts. This is a time-consuming and manual process, and while it would normally take several months, the local boards will be performing this process in three weeks.

Ms. Charlson shared that we have on our website a <u>redistricting landing page</u> and direct people there from information on our homepage. We explain on our <u>Voter Look-Up</u> what information is shown (*i.e.*, voters' "current" district and polling place information) and ask voters to check back to see their updated district and polling place information. Redistricting information also appears on the candidate list and will be added to sample ballots and mail-in voting instructions.

## Clear Ballot Annual User Conference

On the afternoons of April 29 and 30, Ms. Hartman participated in the Clear Ballot Second Annual User Conference, which was held virtually. Following with the theme of "Charting the Course," the 200-plus attendees participated in panel discussions, breakout sessions, and heard from speakers that highlighted using Clear Ballot's current and upcoming suite of products to navigate successfully through an election cycle. Ms. Hartman gave a short presentation during the second session on April 29, which was dedicated to customer spotlight. She explained how Maryland uses Clear Ballot to conduct a 100% independent automated tabulation audit of all election results statewide to confirm the accuracy of the voting system results.

## **Election Reform and Management**

## Replacement Early Voting Centers and Drop Box Locations

SBE staff are working with the local boards to review proposed replacement locations for early voting centers and resulting ballot drop boxes moves for the July 19 Primary Election. The State Board approves early voting centers, while the State Administrator approves ballot drop box locations.

#### Call Center

Since the 2010 elections, we have used a call center to assist us in responding to the voters of Maryland. These services began with assisting SBE and then several of the larger local boards. In 2020, the call center answered over 182,600 inquiries for SBE and about 18 local boards. For the 2022 elections, we are utilizing this service to help our voters get answers to their questions. Currently, the call center is handling calls for SBE and nine local boards, and another two local boards are scheduled to come onto the system. As of April 24, a total of 14,855 inquiries have been handled.

## **Voter Registration**

#### **MDVOTERS**

Several local boards procured high speed envelope sorting solutions. Development to allow MDVOTERS and the sorting solution software to exchange data was in the 8.4 release, which was placed into production on April 22. This release also implements an additional level of security by adding screen lock messaging requiring the user to "log" back in after sitting idle after an allotted time.

To support the redistricting process, MDVOTERS created a "snapshot" of data which will enable the local boards to review prior districts and precincts if need be.

#### **MDVOTERS** Audits

Monthly audits of voter registration data continue to verify compliance with federal and State laws governing voter registration. The monthly audits include review of the local boards of elections' processing of Electronic Registration Information Center (ERIC) reports, Department of Health and Mental Hygiene (DHMH) death records, Administrative Office of the Courts (AOC) felony records, and the processing of overall voter registration records. Follow up is conducted with the local boards to ensure all corrections are completed and to address any training issues. On a monthly basis, a minimum of 144 audits are conducted.

## Electronic Registration Information Center (ERIC) - Membership

ERIC's membership now has 31 states plus the District of Columbia. For more information on ERIC, please visit <a href="https://ericstates.org/">https://ericstates.org/</a>.

#### **ERIC Files**

We are now receiving ERIC data on a monthly basis. On even months (February, April, etc), we receive the In-State Updates, Cross-State, and NCOA (National Change of Address) reports for processing. Odd months bring us the In-State Duplicate and Social Security Administration Death files for processing. Now that we are within 90 days prior to an election and prohibited from sending list maintenance mailings, we will receive the In-State Duplicate and SSA Death files monthly.

## Motor Vehicle Administration (MVA) Transactions

During March, MVA collected the following voter registration transactions:

New Registration - 11,750 Residential Address Changes - 20,529 Last Name Changes - 2,445 Political Party Changes - 3,545

#### Non-Citizen Registration and Voting

From March 1, 2022 to April 19, 2022, a total of 364 voters have been canceled due to these voters not being U.S. citizens. Six voters have voting history. SBE will review these records prior to submitting them to the Office of the State Prosecutor.

## **Candidacy and Campaign Finance (CCF) Division**

#### Candidacv

The candidacy filing deadline was changed by the Court of Appeals from February 22, 2022, to March 22, 2022, and then to April 15, 2022 at 9 pm. The candidacy filings were scheduled by appointment, and as of April 20, 2022 (after the deadline to withdraw and central committee filling vacancies), 589 candidates have filed at SBE. Mr. DeMarinis thanked the CCF Division for their hard work over may months to successfully file candidates for office.

## Campaign Finance

State Public Financing Program

In order to qualify for a public contribution, the candidate must raise \$120,000 from 1,500 Maryland residents. One gubernatorial candidate has been certified and qualified for \$722,663.68 in public funds. This marks the third consecutive gubernatorial election with a certified public financed candidate.

## County Public Financing Programs

Montgomery County: There are 17 certified candidates in the program. Eight additional candidates have filed a notice of intent to participate. The program has disbursed \$168,873 in March and an aggregate disbursement total of \$1,973,207.

Howard County: There are two certified candidates in the program. Four more candidates have filed a notice of intent to participate in the program. As of April 5, the program has disbursed a total of \$561,284.49.

## Website Activity

In March, the MD Campaign Reporting Information System (MD CRIS) website was visited by 305,773 individuals for an average of 9,863 per day. Additionally, it had 1,953,545 hits. Each viewer looked at an average of approximately five page views per day. The Business Contribution Disclosure System (BCDS) website had 861,441 hits, with 68,306 visitors with an average of nearly twelve page views per day.

## **Enforcement**

## **Voting Systems**

#### New Electronic Pollbook

Work on implementing the new electronic pollbooks continues. Mr. Brechbiel reported that we are simultaneously in the Project Initiation and Planning and the Analysis and Design phases. The project initiation and planning phase is on schedule for completion in the second quarter of 2022, and the analysis and design phase is on schedule for completion in the third quarter of 2022.

## **Voting System Replacement Project**

Mr. Brechbiel reported that the current voting system lease ends March 2023, and there is one option remaining. If exercised, the final option ends March 2025. We are currently gathering information about current and future voting system solutions and are on schedule to complete this phase by the third quarter of 2022.

## **Project Management Office (PMO)**

## **Inventory Management**

SBE's FY22 Inventory Auditing of equipment and supplies statewide started on February 1. Mr. Ross reported that currently, over 90% of the inventory has been audited, with a completion date of June 30, 2022, for auditing to be completed.

## **Document Management**

There is currently an active Request for Information (RFI) solicitation requesting information from document management system vendors. The closing date for responses is April 29. SBE will review the responses and move forward with developing the requirements for a Request for Proposals (RFP) that is expected to go out for bids later this year.

## **Baltimore City Relocation**

The PMO continues to work with the Baltimore City Board of Elections on their office and warehouse relocation plans. Mr. Ross worked with the local board to develop the space calculations worksheets that helped understand the square footage needed. The local board continues to check into possible facilities in the city to relocate.

## **Election Operations Support**

The PMO is working on the logistics and planning for the upcoming primary election operations support, including using an election helpdesk system and the setup of an election operations center on election day.

## **Information Security**

## Managed Security Services (MSS)

After a competitive procurement, a new vendor - Digital Lantern LLC of Hanover, Maryland – was selected to monitor, notify and respond to our election systems and data hosted by our data center. The contract was before the Board of Public Works for approval at its April 27 meeting, which Ms. Charlson reported was approved.

## <u>Disaster Recovery</u>

SBE's *Disaster Recovery Plan* has been updated for 2022, presented and made available to SBE staff. The updated DR plan incorporates staffing and contact changes related to local boards, SBE, and SBE vendors and partners. Updates also include procedural updates for all critical applications and systems and media communications. Additional updates include critical information and procedures related to SBE's security operations center, primary network operations center and continuity of operations center.

## **Election Security**

As we prepare for the 2022 midterm elections, SBE continues to mature its information security program to anticipate, detect and respond to an ever-evolving cyber threat landscape. These efforts include several ongoing initiatives:

- Updating cybersecurity policies to further define requirements specific to SBE IT and operations and development. These policies are compliant with federal NIST 800-53, NIST Cybersecurity Framework, and Department of Information Technology guidelines.
- Defining detailed technical standards based on these policies and industry best practices to help to secure and defend SBE data and systems.
- Implementing training and managed security services to enhance our capabilities to detect and respond to threats to SBE systems and the election process.
- Social Media Defense to help SBE identify and quickly respond to malicious threats via social media such as impersonation of election officials, voting misinformation, registration scams and threats of violence.
- Undergoing cybersecurity audits and assessments to assure compliance with policies and best practices.

- Conducting regular penetration testing and vulnerability detection to test and improve SBE's cybersecurity posture.
- Conducting quarterly tabletop exercises, to practice and improve our incident response for threats of all kinds (including ransomware, malware, misinformation, supply-chain software vulnerabilities, etc.).
- Implementing industry-standard tools which help our teams detect and respond to cyber vulnerabilities and attacks quickly and effectively.

In light of current global events, SBE is working closely with federal and State partners to maintain increased cybersecurity alert and readiness levels. Our close partnerships with federal, State, and local partners including Cybersecurity Infrastructure Security Agency, federal Department of Homeland Security, FBI, and the local boards have provided useful and effective resources and services to support the cybersecurity program.

Ms. Charlson noted that the above election security report is the quarterly report that we provide to the Board.

## Legislation

A list of legislation passed in the 2022 Session of the General Assembly was included with the meeting materials. Ms. Duncan noted that of the final list is significantly shorter than the approximately 150 bills we were following. All may not receive the signature of the Governor, but that will be determined over the next several weeks. Ms. Duncan deferred further explanation to Mr. DeMarinis and Ms. Wagner.

Mr. DeMarinis stated that both departmental bills passed and are just waiting on the Governor's signature. He also stated that both initiatives of the Maryland Association of Election Officials (MAEO) passed – one bill allowing local boards to open mail-in ballots prior to election day, and another repealing the prohibition of having a polling place or early voting center at a location that also has a liquor license. Mr. DeMarinis stated that the latter bill requires regulations which he will present to the Board at its next meeting. Ms. Wagner thanked the SBE legislative team and Katie Berry, Election Director for Carroll County and MAEO's Legislative Committee Chair, for their hard work during the legislative session.

Ms. Lamone also thanked everyone at SBE and the local boards involved with the legislative session and candidate filings.

#### ASSISTANT ATTORNEY GENERAL'S REPORT

Mr. Snyder stated that he was filling in for Andrea Trento, who recently departed the Office of the Attorney General. He thanked Mr. Trento for his thorough and excellent work before his departure. Mr. Snyder provided the following updates but noted that all cases have concluded except for *In the Matter of Seth Wilson*:

1. WinRed, Inc. v. Ellison, et al., No. 21-cv-1575 (D. Minn.). On July 7, 2021, WinRed, Inc. – a federal PAC created to assist Republican Party candidates – filed a lawsuit against the Attorneys General of Connecticut, New York, Maryland, and Minnesota (the "State AGs"), seeking a declaration that State consumer protection statutes and regulations are preempted by federal law, to the extent that these State laws are being enforced to regulate the use of pre-checked recurring contribution boxes for solicitations for federal offices. WinRed had received letters from the defendants requesting information and documents regarding its use of pre-checked boxes in that context. (It is now public that

ActBlue – the PAC formed to assist Democratic Party candidates – has received a similar request from the same State AGs but has not joined this lawsuit.) On July 27, 2021, WinRed filed a motion for preliminary injunction against enforcement of subpoenas served by the State AGs. On July 29, 2021, the State AGs moved to dismiss the complaint. Oral argument on both motions took place on November 2, 2021. On January 26, 2022, the Court issued an order denying Plaintiff's motion for preliminary injunction and granting the defendants' motion to dismiss and dismissed the Complaint. WinRed has appealed the dismissal to the U.S. Court of Appeals for the Eighth Circuit. On March 25, 2022, WinRed filed its opening brief, in which it made clear that it is not challenging the district court's ruling dismissing WinRed's claims against Maryland, Connecticut, and New York. Maryland then joined in submitting a letter with the appellate court clarifying that we will not be participating in the appeal unless otherwise instructed by the court. Minnesota's brief is due April 28, 2022.

2. Conners v. State of Maryland, et al., No. C-02-CV-21-001282 (Cir. Ct. A.A. Cnty.). On September 23, 2021, the Plaintiff filed a lawsuit challenging the SBE's disclosure of personalized voter information on lists of registered voters without obtaining voters' consent. She alleges that SBE's practices of (i) disclosing information beyond just the names of voters on the voter list, (ii) disclosing the voter list to non-Maryland registered voters, (iii) transmitting the voter list to individuals or organizations who do not swear the oath that the list will only be used for electoral purposes, (iv) failing to ensure that the purpose for which the list is intended to be used by the applicant comports with that requirement, and (v) allowing only some voters to participate in the voter confidentiality program, violates various State and federal laws and constitutional provisions. The plaintiff is seeking, among other things, damages in the amount of \$400,000 for each instance her voter information was disclosed on a voter list transmitted to an applicant, and seeks injunctive relief in the form of an order forbidding SBE from disclosing voter information without the affirmative consent of the voter and requiring SBE to issue new voter ID numbers to every Maryland registered voter. The State of Maryland, the State Administrator, and the Governor are named as defendants in the case.

Meanwhile, on November 8, 2021, the Defendants filed a motion to dismiss the Complaint. On November 23, 2021, Plaintiff filed an opposition to the motion to dismiss. The motion to dismiss was heard on February 14, 2022. On March 10, 2022, the Circuit Court issued an opinion and order dismissing the Complaint. There is no indication that Plaintiff appealed that decision by the April 12 deadline for doing so.

3. Baltimore Cnty. Branch of the NAACP, et al. v. Baltimore Cnty., Md., et al., No. 1:21-cv-03232 (D. Md.). On December 21, 2021, the Baltimore County Branch of the NAACP, the League of Women Voters, Common Cause of Maryland, and several individual plaintiffs filed a lawsuit challenging the Baltimore County redistricting map for county council districts, on the ground that it violated section 2 of the Voting Rights Act. Baltimore County, the individual members of the Baltimore County Council, and the Baltimore County Board of Elections were named as defendants. (The individual County Council members have since been dismissed from the case.) On January 19, 2022, the plaintiffs filed a motion for preliminary injunction, and the court entered an order setting a hearing for February 15, 2022 on the plaintiffs' motion. On February 22, 2022, the court ruled in favor of the plaintiffs, and ordered Baltimore County to produce a compliant map by March 9, 2022. On March 9, 2022, Baltimore County filed its proposed remedial map. The Court has asked the plaintiffs to respond to the filing by 5 pm on March 10, 2022, and held a conference

with the parties on March 11, 2022 to discuss further proceedings. On March 25, 2022, the Court approved the remedial map proposed by Baltimore County. By April 29, 2022, the parties must file a joint status report setting forth their respective views on whether the Court should dismiss this matter, or, if warranted, proposing a schedule for further proceedings.

4. Parrott, et al. v. Lamone, et al., No. C-02-CV-21-001773 (Cir. Ct. A.A. Cnty.); Szeliga, et al. v. Lamone, et al., No. C-02-CV-21-001816 (Cir. Ct. A.A. Cnty.). On December 21 and 23, 2021, respectively, two groups of individual plaintiffs filed lawsuits challenging the State's Congressional redistricting map under various provisions of the Maryland Constitution. Collectively, plaintiffs allege that the map is an unlawful partisan gerrymander under Articles 7, 24 and 40 of the Declaration of Rights, and Articles I, § 7 and III, § 4 of the Maryland Constitution. The defendants named in the lawsuits are Ms. Lamone, Mr. Voelp, and the State of Maryland. On January 21, 2022, the Democratic Congressional Campaign Committee filed motions to intervene in both cases. These motions were rejected by the Court.

On February 7, 2022, the defendants moved to dismiss the Complaint in the *Szeliga* matter. The Court ordered an expedited response to that motion, and scheduled argument for February 16, 2022. On February 11, 2022, the *Parrott* plaintiffs moved to intervene in the *Szeliga* matter for the purpose of participating in the briefing and argument on the motion to dismiss. Argument took place on February 16, 2022. The parties made further submissions to the Court on February 18, 2022, and the Court ordered further argument on February 23, 2022. Following argument, on February 23, 2022, the Court denied the defendants' motion to dismiss as to all but one of the plaintiffs' claims and set a schedule for further proceedings in the case.

A four-day trial took place beginning March 15, 2022. On March 25, 2022, the Court issued its memorandum opinion and order, concluding that the congressional redistricting map violated the Maryland Constitution, and ordering the General Assembly to produce a new map for the Court's review by March 30, 2022. On March 30, 2022, the State filed notices of appeal to both the Court of Appeals and the Court of Special Appeals, and the Szeliga plaintiffs' filed notices of cross-appeal to both courts. On that same day, the State submitted to the Court the new map passed by the General Assembly (SB 1012), which was contingent on the Court of Appeals upholding the Circuit Court's ruling or the appeal otherwise being dismissed. On April 1, 2022, the Court held a hearing on the sufficiency of the new map but concluded that it could not approve or deny the new map on the merits due to the fact that the enactment was not yet final (as it lacked Governor Hogan's signature or had not otherwise become law in the absence of such signature or as a result of a veto override). On April 4, 2022, Governor Hogan signed SB 1012 and both sets of appeals were dismissed.

5. *In the Matter of Seth Wilson*, No. C-02-CV-22-000078 (Cir. Ct. A.A. Cnty.). On January 14, 2022, Seth Wilson, the Chairman of the Washington County Republican Party Central Committee, filed a petition for judicial review of the determination and approval, respectively, by the Washington County Board of Elections and SBE, of the locations for early voting centers in Washington County for the 2022 elections. On January 19, 2022, the agencies were provided notice of the petition for judicial review by the Clerk of the court. On March 22, 2022, the agencies filed administrative records. The petitioner filed

his memorandum of law on April 21, 2022. A hearing on the petition has been scheduled for August 15, 2022.

6. In the Matter of 2022 State Legislative Redistricting, Misc. Nos. 21, 24, 25, 26, 27 (Md.). On January 28, 2022, the Court of Appeals promulgated procedures for challenging the State legislative district map promulgated by the General Assembly. The Court established a deadline of February 10, 2022, for the filing of challenges, and ordered the Attorney General's Office to respond to any such challenges by February 15, 2022. The Court appointed Retired Judge Alan Wilner to serve as Special Magistrate to preside over these proceedings.

On February 10, 2022, four separate petitions were filed challenging various aspects of the State legislative district map. On February 15, 2022, the State filed motions to dismiss each petition. On February 18, 2022, Judge Wilner entered a scheduling order requiring that the parties exchange discovery by March 11, 2022 and submit proposed findings of fact by March 22, 2022. A two-day hearing took place beginning March 23, 2022. On April 4, 2022, Judge Wilner issued his recommendation to the Court of Appeals, recommending that all four of the petitions be denied. On that same day, the Court of Appeals issued a scheduling order directing the parties to file any exceptions to Judge Wilner's recommendation no later than April 8, 2022, at 4:30 pm, and any responses to those exceptions no later than April 11, 2022, at 4:30 pm, and scheduled a hearing on the petitions on April 13, 2022. The Court also directed the State to file a memorandum regarding the State's ability to conduct the primary election on July 19, 2022 and including any recommendations for alternative election dates.

On April 13, the Court of Appeals issued an order denying the petitioners' exceptions to Judge Wilner's recommendation and upholding the Legislative Redistricting Plan of 2022 enacted as Senate Joint Resolution 2 on January 27, 2022. In addition to denying exceptions, the Court ordered that the primary election shall continue to be scheduled for July 19, 2022, and confirmed certain other deadlines set forth in its March 15 Order. The deadlines were initially reduced from what the corresponding statutory provisions required, but on April 25 the Court—in response to Petitioners' unopposed motion—extended those deadlines somewhat to more closely match the statutory deadlines. Accordingly, the deadline for filing certificates of candidacy was (and remains) April 15; the deadline to withdraw candidacy was adjusted to April 25 (i.e., the full ten days that Elec. § 5-502(a) allows); and the deadline for filling vacancies resulting from the withdrawal of candidates is now April 27 (this date was moved back from April 20 to match the extension of the withdrawal deadline, but it still represents a truncated deadline, as Elec. § 5-901 would ordinarily allow four days after the withdrawal deadline to fill vacancies).

7. In re Petition for Declaratory Ruling by Del. Mary Ann Lisanti (State Bd. of Elec.). On March 7, 2022, Delegate Mary Ann Lisanti filed a petition for Declaratory Ruling asking the State Board of Elections to rule on the propriety of the Harford County Board of Elections' implementation of the new councilmanic district map. The petition notes that the textual provisions of the bill that was passed by the County Council implementing the map are inconsistent with the map that was included with the bill. The local Board of Elections opted to effectuate the map version of the bill, as opposed to the textual version of the bill. The State Board must rule within 60 days or notify the petitioner within that period of time of any reasons for which it will not issue such a ruling.

# APPROVAL OF PROPOSED REGULATIONS TO COMAR 33.14 (ADMINISTRATION OF PUBLIC FINANCING ACT)

Mr. DeMarinis presented proposed new and amended regulations to COMAR 33.14. He explained that the 2021 Legislative Session of the General Assembly completely overhauled the public financing program for Governor (Chapter 733, SB 415) The new law modeled after the successful County program features a robust tiered fund matching for small dollar contributions and the elimination of an expenditure limit. Additionally, the program has for the first time in its existence a secured source of funds to maintain its viability as a program in future years. The program no longer distinguishes between the primary and general election. Once a candidate intends to participate in the program, the candidate must participate for all elections that candidate is eligible to appear on the ballot. The regulations proposed reflect the changes in the law.

The proposed new and amended regulations are:

## **Chapter .01: Definitions, General Provisions**

- **.02 Definitions**: The proposed regulation eliminates terms no longer applicable and replaces outdated terms with new definitions.
- **.03 Agency Responsibilities- Comptroller:** The proposed regulation and the new law require that the Comptroller provide monthly statements of the Fair Campaign Financing Fund. The regulation replaces an outdated term and repeals an obsolete requirement.
- **.04 Agency Responsibilities- State Board**: The proposed regulation repeals outdated requirements.

## **Chapter .02: Eligibility Requirements and Procedures**

- **.01 In General**: The proposed regulation clarifies the process to establish a public financing committee and states the threshold requirements to be certified to receive public funds.
- **.02 Special Circumstances**: The proposed regulation conforms an uncontested gubernatorial election and unaffiliated and write-in candidates to the current requirements of the program.
- **.03 Deadline for Notice and Certification- Primary Election**: The proposed regulation codifies the deadlines for submission of a certification request for a candidate in the Primary Election.
- **.04 Deadline for Notice and Certification- General Election**: The proposed regulation codifies the deadlines for submission of a certification request for a candidate only appearing in the General Election.
- **.05 Requests for Public Contribution**: The proposed regulation establishes the filing periods for submission of a request to receive a public contribution. Additionally, the proposed regulation set forth the necessary information and supporting documents to be included with the filed campaign finance report.
- **.06 Withdrawal from Public Financing**: The proposed regulation repeals outdated requirements. The proposed regulation is updated with the process for withdrawal from the program.
- **.07** [Request for Contributions- General Election] Candidate Contributions or Loans: The proposed regulation repeals outdated requirements. The proposed regulation is updated with

the process for the attribution of a candidate loan or contributions toward the contribution and monetary qualifying thresholds.

- **.08 Determination of Eligibility**: The proposed regulation repeals outdated requirements. The proposed regulation is updated that the State Board shall determine certification within 10 business days of the initial request.
- **.09 Distributions:** The proposed regulation codifies that the first disbursement may not occur other than in the year of the election. Additionally, the State Board shall process supplemental requests for public contribution within 5 business days.
- **.10 Post Election [Returns]:** The proposed regulation repeals outdated requirements. The proposed regulation is updated that the certified gubernatorial ticket committee shall file a final report 90 days after last appearing on the ballot. The committee shall return any unspent portion of the public contribution to the Fair Campaign Financing Fund.
- **.11 [Seed Money] In-Kind Contributions and Candidate Contributions:** The proposed regulation repeals outdated requirements. The proposed regulation is updated that the certified gubernatorial ticket committee may receive an in-kind contribution but will not be eligible for a public contribution match. Additionally, the proposed regulation makes a candidate contribution not eligible for a public contribution match.
- **.12 Eligible Private Contributions:** The proposed regulation repeals outdated requirements. The proposed regulation conforms to the new statutory requirements for an eligible private contribution. The proposed regulation codifies those past contributions to a candidate would count towards the aggregate the candidate is eligible to receive. If a contributor is over the limit, the prior campaign finance entity of the candidate may return the past contributions received.
- **.13 Electronic Signatures:** The proposed new regulation sets forth the requirements to accept an electronic signature on a contribution card. Mr. DeMarinis noted that these new requirements to accept and electronic signature are not required by the new law but rather are best practices learned from the program at the county level.

#### Chapter .03: [Limitations on] Campaign Expenditures

- **.01 In General:** The proposed regulation repeals outdated requirements for an expenditure limit. The proposed regulation is updated with the requirements for submission of an expenditure. The proposed regulation requires every expenditure made on behalf of the gubernatorial ticket committee be supported with a receipt.
- **.02 Central Committee:** The proposed regulation allows for central committees to make coordinated in-kind contributions to county publicly financed candidates. The proposed regulation set limits and the source of the funding consistent with the enabling legislation
- **.03 [Political Committee]:** The proposed regulation repeals outdated regulation and keeps the numbering in reserve.
- **.06 In-Kind Contributions:** The proposed regulation changes terms to be consistent with the other provisions in COMAR and Title 15 of the Election Law Article.

**.07 Prior Expenditures:** The proposed regulation repeals the outdated regulation. The proposed regulation requires all campaign finance activity must cease unless conducted through the public financing committee once a notice of intent has been filed. The proposed regulation permits certain enumerated prior expenditures to be assumed by the public financing committee without penalty or payment.

## <u>Chapter .04: Disbursement and Expenditure of Public Contribution</u>

- **.03 [Supplemental Public Contribution]:** The proposed regulation repeals outdated regulation and keeps the numbering in reserve.
- .04 Single Campaign Fund Required: The proposed regulation requires a gubernatorial ticket committee to maintain one bank account consistent with the rules and regulations for a political committee.
- **.05 Prohibited Uses of Public Contribution:** The proposed regulation updates terms to be consistent with the current law and changes the deadlines to 45 days for the final payment for services rendered to the gubernatorial ticket committee instead of 30 days.
- **.06** [**Reports**]: The proposed regulation repeals the outdated regulation and keeps the numbering in reserve.

## **Chapter .05: Outstanding Obligations**

- **.01 Outstanding Obligations:** The proposed regulation repeals the outdated regulation and requires the payment of all outstanding obligations prior to the filing of the final report.
- **.02 [Post-Primary Election] Fundraising:** The proposed regulation repeals the outdated regulation. The proposed regulation allows for a gubernatorial ticket committee to continue to fundraise in a new election cycle to satisfy any outstanding obligation it incurred during the election.

In response to questions from Mr. Voelp, Mr. DeMarinis gave the following responses:

- 1. He noted that the schedule of matching fund filing request deadlines as presented in the amended COMAR 33.14.02.05 is not explicitly stated in the new law but stems from current the current deadlines for county level offices.
- 2. He noted that the proposed amended COMAR 33.14.03.07 requires that all campaign finance activity must cease unless conducted through the public financing committee once a notice of intent has been filed.
- 3. He clarified that the electronic signatures allowed under the proposed new COMAR 33.14.02.13 are in line with electronic signatures allowed under Title 13 and allow for the administrative convenience of a candidate being able to receive a credit card donation online and collect the required signature at the same time. Requiring a wet signature for an online donation is highly inefficient. In response to a comment from Mr. Funn, Mr. DeMarinis clarified that other types of digital donations (e.g., Venmo, Zelle, etc.) are allowed for public campaign financing candidates, but the donor would still be required to complete the donor card and sign electronically.

Mr. Funn made a motion to approve the proposed amendments to COMAR 33.14, as presented by Mr. DeMarinis. Mr. Miller seconded the motion. The motion passed unanimously.

#### APPROVAL OF REPLACEMENT EARLY VOTING CENTERS

Ms. Dorsey presented requests for approval of replacement early voting centers from the Anne Arundel, Baltimore, Caroline, Cecil, Charles, Frederick, Harford, Howard, Prince George's, and Worcester County Boards of Elections. - 1. <u>Anne Arundel</u>- Ms. Dorsey presented a request from the Anne Arundel County Board of Elections to replace five early voting centers for the primary election only. SBE recommended approving this request.
- 2. <u>Caroline County</u>- Ms. Dorsey presented a request from the Caroline County Board of Elections to replace one early voting center the James F. Fettered Community Center with the Caroline County Health and Public Services Building for both elections. SBE recommended approving the request.
- 3. <u>Cecil County</u>- Ms. Dorsey presented a request from the Cecil County Board of Elections to replace one early voting center –the Cecil Arena with Calvert Elementary School for the primary election only. SBE recommended approving the request.
  - Ms. Woodward made a motion to approve the requests for replacement early voting centers, as presented by Ms. Dorsey, in Anne Arundel, Caroline, and Cecil Counties. Mr. Funn seconded the motion. The motion passed unanimously.
- 4. <u>Charles County</u>- Ms. Dorsey presented a request from the Charles County Board of Elections to replace one early voting center –St. Joseph's Hall with St. Joseph's Activity Center for the primary election only. SBE recommended approving the request.
- 5. <u>Frederick County</u>- Ms. Dorsey presented a request from the Frederick County Board of Elections to replace one early voting center the Frederick Senior Center with Trinity Recreation Center for both elections. SBE recommended approving the request.
- 6. <u>Harford County</u>- Ms. Dorsey presented a request from the Harford County Board of Elections to replace one early voting center Jarrettsville Fire Hall with Jarrettsville Elementary School for the primary election only. SBE recommended approving this request.
- 7. <u>Worcester County</u>- Ms. Dorsey presented a request from the Worcester County Board of Elections to replace one early voting center Roland Powell Convention Center with Worcester Preparatory School for the primary election only. SBE recommended approving this request.
  - Mr. Funn made a motion to approve the requests for replacement early voting centers, as presented by Ms. Dorsey, in Charles, Frederick, Harford, and Worcester Counties. Mr. Miller seconded the motion. The motion passed unanimously.
- 8. <u>Baltimore County</u>- Ms. Dorsey presented a request from the Baltimore County Board of Elections to replace six early voting centers –five centers for the primary election only and one center for both elections. SBE recommended approving these requests.

- 9. <u>Howard County</u>- Ms. Dorsey presented a request from the Howard County Board of Elections to replace all five of its early voting centers. SBE recommended approving these requests.
- 10. <u>Prince George's County</u>- Ms. Dorsey presented a request from the Prince George's County Board of Elections for one replacement early voting center –Accokeek VFW with the Accokeek Academy for the primary election only. SBE recommended conditionally approving this request pending approval by the Prince George's County Board of Elections.

Mr. Funn made a motion to approve the requests for replacement early voting centers, as presented by Ms. Dorsey, in Baltimore and Howard Counties. Mr. Miller seconded the motion. The motion passed unanimously.

Mr. Funn made a motion to conditionally approve the request for the replacement early voting center, as presented by Ms. Dorsey, in Prince George's County. Mr. Miller seconded the motion. The motion passed unanimously.

#### APPROVAL OF DECLARATORY RULINGS

Mr. DeMarinis presented requests from two individuals requesting declaratory rulings. According to COMAR 33.01.02.01, Mr. DeMarinis explained that the purpose of a declaratory ruling is for a petitioner to know how the State Board would apply a regulation, order or a statute to any person or entity.

## Petition #1- George Gluck

On February 22, 2002, we received a petition for a declaratory ruling ("the Petition") pursuant to COMAR 33.01.02 from Mr. Gluck ("Petitioner #1"). Petitioner #1 seeks to file a declaration of intent for multiple public offices simultaneously. The issue presented is whether an individual may seek the nomination of a non-principal political party for multiple public offices simultaneously.

Based upon the facts and issues presented, we recommend that the State Board should 1)issue a declaratory ruling, and 2) should decide that Petitioner #1 cannot file declarations of intent for multiple public offices.

In response to a question from Mr. Voelp, Mr. DeMarinis confirmed that Mr. Trento reviewed the petition prior to his departure and agreed that a person can not file declarations of intent for multiple public offices.

Mr. Voelp confirmed, to which Mr. DeMarinis agreed, that the options the Board could take are to approve the petition, to deny the petition, or determine that the Board does not have jurisdiction over the question presented in the petition.

Mr. Funn made a motion to issue a declaratory ruling stating that a person can only declare an intent to run for one public office at a time. Mr. Miller seconded the motion. The motion passed unanimously.

#### Petition #2- Delegate Mary Ann Lisanti

On March 7, 2022, the State Board received a petition for declaratory ruling regarding the discrepancies on election boundaries under Election Law Article §4-103(a) (the "Petition #2") from Delegate Mary Ann Lisanti (the "Petitioner #2"). The issue presented is whether an approved redistricting map supersedes the text of the redistricting legislation if a discrepancy is

discovered. Based upon the facts and issues presented, we recommend that the State Board not issue a declaratory ruling on the matter because the declaratory ruling process is an incorrect venue for the action sought by the Petitioner #2.

In response to a question from Mr. Williams, Mr. DeMarinis stated that the correct venue to clarify the discrepancy between the redistricting map and legislation text would be the Harford County Council or through the judicial system.

Mr. Funn made a motion to decline to issue a declaratory ruling stating because the State Board of Election is the incorrect venue to respond to make the determination requested in Petition #2. Ms. Woodward seconded the motion. The motion passed unanimously.

## APPROVAL OF AMENDED BYLAWS FOR BALITMORE COUNTY

Ms. Hartman presented amended bylaws for the Baltimore County Board of Elections, which were approved unanimously by the local board at its February 2022 meeting. The amendment includes the addition of text to the Special Meetings subsection to require notification of special meetings by text message and email to board members duties with confirmation required. New text is italicized. Specifically, the amendment is as follows in italicized text:

**Article 3- Meetings** 

Section 3.1- Time and Locations

E. Special Meetings. The president or a majority of the Board making application to the President may call a special meeting. However, no votes may be taken at a special meeting unless three days prior notice has been given to all members, staff and the public. *There shall be notification by cellphone text messaging and email to all Board members when calling any meetings not regularly scheduled. Acknowledgment must be received to ensure all members have been adequately notified.* 

In reviewing the amended Bylaws, Ms. Woodward, Mr. Williams, and Mr. Snyder made additional typographical suggestions for the document, which Ms. Hartman stated she would relay to the local board.

In response to a question from Mr. Funn regarding if a Board member does not have both a cell phone to receive a text message and a computer to receive email, Ms. Charlson clarified that the bylaws are applicable to current board members only. Because this amendment was approved by the local board of elections, the members have already agreed to the proposed terms.

There was no further discussion on the approval of the proposed amended bylaws. Ms. Woodward made a motion to adopt the amended bylaws for the Baltimore County Board of Elections. Mr. Miller seconded the motion. The motion passed unanimously.

In response to a question from Mr. Williams regarding if the State Board needed to update its bylaws, Ms. Charlson stated that we have updated the Delegation of Duties document which accompanies the bylaws. That document and the bylaws are currently under review, and we plan to present those documents at the next meeting for adoption.

#### **OLD BUSINESS**

There was no old business.

#### **NEW BUSINESS**

## Speaker

Nicole Hanson-Mundell- Executive Director, Out for Justice

Ms. Hanson-Mundell, on behalf of the of Out for Justice and other voting advocacy organizations, proposed changes to the voter registration application oath describing eligibility of persons with convictions. Specifically, on the paper version of the application, she proposed changing the wording from "Not have been convicted of a felony, or if you have, you have completed serving a court-ordered sentence of imprisonment." to "Not be currently serving a sentence of imprisonment for a felony conviction."

Similarly, in the online voter registration system, Ms. Hanson-Mundell proposed changing the fifth required affirmation before signing the application from: "One of the following is true:

- I have not been convicted of a felony.
- I have been convicted of a felony, but I have completed serving a court-ordered sentence of imprisonment." to "I am not currently serving a sentence of imprisonment for a felony conviction."

Ms. Hanson-Mundell explained that, while individuals who have completed incarceration for a felony or are awaiting trial and have not yet been convicted are eligible to vote, many of those eligible voters are not aware that they are eligible.

In response to a question from Ms. Woodward regarding the need for this change at this time, Ms. Hanson-Mundell stated that despite the law being in existence since 2015, most of the eligible voters who were previously incarcerated for a felony, or who are awaiting trial and have not yet been convicted, do not know that they have the right vote. She states that simplifying the language on the application removes another barrier to voting.

Ms. Woodward stated that she is sympathetic to the issue presented but stated her reservations that the State Board does have the authority to make the changes requested and that the revised language is the correct language to use. She noted how the revised versions of the mail-in ballot application went through a rigorous review by linguists from the University of Baltimore and would want a similar review for any other changes made to public-facing documents.

After much discussion, Mr. Voelp proposed that for the next meeting, the staff prepare a timeline for implementing a change such as the one proposed by the speaker. No members objected.

Ms. Hanson-Mundell thanked the Board for their time. There was no further discussion.

## Administrator's Report – June 2022

## **Announcements & Important Meetings**

## SBE Employees in New Positions

Donna Duncan has moved to a new position at SBE. Donna is now the Assistant Deputy for Constituent Relations and is responsible for outreach and communications to all of our stakeholders. This change is mostly in name only since Donna has been performing these duties for many years, but since it has evolved into a full-time effort, we decided to make it a dedicated position.

Melissia Dorsey is now the Assistant Deputy for Election Policy, the position Donna formerly held. Melissia will continue to oversee the Election Reform and Management Division (where she was previously the Director) and the Voter Registration and Petition Division. The Director of the Election Reform and Management Division is now vacant and we are recruiting to fill that position.

## **Election Directors' Meetings**

We hosted an Election Director's meeting on May 12, 2022, and on June 2, 2022, we will begin a series of weekly meetings leading up to the election. The topics of discussion cover the current election preparation tasks and any specific topics or questions requested by the Election Director's. As the minutes of the meetings are prepared, they will be included with the County Bulletin.

## **Election Reform and Management**

## **Ballots**

Over 5,000 by-precinct ballots were recently created by Natasha Walker and reviewed and proofed by the local boards of elections. Before going to the by-precinct ballot, the usual number of ballot styles was approximately 700 to 800. This is a significant change that was managed within shortened deadlines due to redistricting litigation. The 5,000 ballots are multiplied about four or five times to provide different sources with the exact format needed for different tasks.

#### Call Center

Since the 2010 elections, we have used a call center to assist us in responding to the voters of Maryland. These services began with assisting SBE and then several of the larger local boards. In 2020, the call center answered over 182,600 inquiries for SBE and about 18 local boards. For the 2022 elections, we are utilizing this service to help our voters get answers to their questions. Currently, the call center is handling calls for SBE and twelve local boards, and another local board is scheduled to join the call center when the ballots are mailed. As of May 27, 2022, a total of 17,292 calls have been handled.

#### Mail-in Voting

Another round of mail-in ballot request forms will be mailed next week. This mailing will be sent to three groups of voters (about 600,000 voters) - (1) Democrats and Republicans who registered to vote after our initial data pull in December; (2) Democrats and Republicans who provided a new address after the initial data pull; and (3) unaffiliated voters and voters affiliated with other political parties who have a ballot for the primary election. We post a report showing the number of processed ballot requests and expect that the number of requests will increase as a result of this mailing.

Under federal law, ballots must be transmitted to requesting military and overseas voters no later than 45 days before an election. June 4 is 45 days before the July 19 election. This week, our mailhouse vendor will mail over 750 ballot packets to requesting military and overseas voters and we will email over 1,650 voters a link to access their ballot via our online ballot delivery system. This schedule means that we will meet the 45-day requirement.

Ballots to all other requesting ballots will be sent next week. Our mailhouse vendor will mail about 350,000 ballot packets on June 9, and we will email about 35,000 voters a link to access their ballot via our online ballot delivery system. After this initial transmission, ballots will be transmitted several times a week until the week before the election.

Each ballot packet will include a list of the ballot drop boxes in that voter's jurisdiction. A statewide list of ballot boxes is available <a href="here">here</a>.

#### USPS

The United States Postal Service (USPS) filed notice with the Postal Regulatory Commission (PRC) of price changes to take effect July 10, 2022. If approved by the PRC, this would include raising First-Class Mail prices approximately 6.5 percent. Beginning January 2023, USPS price adjustments will occur twice a year (January and July) each year.

The Biden administration is looking to give the USPS \$5 billion to support its mail-in voting operations over the next decade. The administration, as part of its fiscal 2023 budget request, expects the money would support vote-by-mail, including making ballots postage-free and reducing the cost of other election-related mail for jurisdictions and voters.

## **Voter Education**

Our voter education campaign kicked off on May 23. The initial messages are registering to vote for individuals who are not registered to vote and checking and updating existing information for voters who are already registered. These messages will be delivered via digital channels (e.g., Google, Facebook, etc). Future phases of the campaign will focus on general messaging about the three ways to vote and voting deadlines. We will use traditional media – TV, radio, and print - as the campaign continues. A few images from the campaign are here. We will soon provide a toolkit for use.



## **Voter Registration**

## Statewide Referendum Petition Effort

The deadline to file a referendum petition effort with the Secretary of State's Office was Tuesday, May 31. This effort is to put a question to the voters on the recently passed legislation, <u>HB 937/Chapter 56</u> - The Abortion Care Access Act. A total of 69,135 valid signatures is required to have the question placed on the ballot at the November general election. A minimum one-third of the total signatures is required for the first filing. The sponsor of this petition effort failed to meet the initial threshold of 23,045 signatures.

## Voter Registration Application Verbiage Change

At the request of the State Board members, SBE staff developed a timeline for the ability to change the verbiage regarding the qualifications of individuals convicted of a felony. These qualifications are found in Election Law Article, §3-102.

## The current language is:

Not have been convicted of a felony, or if you have, you have completed serving a court-ordered sentence of imprisonment.

## The proposed language is:

*Not be currently serving a sentence of imprisonment for a felony conviction.* 

## The timeline for the proposed change is:

- 1. Mock-up of the English version of the voter registration application: Complete
- 2. Notify "automatic registration" agencies about proposed text change: Complete
- 3. Approval of proposed language by the State Board: June 2 meeting
- 4. Obtain Spanish translation of the SBE-approved language: Request by June 6
- 5. Update SBE website and request updates to Attorney General's website: June 6, 2022 (estimate)
- 6. Update SBE's online voter registration system (OLVR): June 6, 2022 (estimate)
- 7. Procure printed voter registration applications: Request for proposals issued on May 26, and bids are due on June 3.
- 8. "Automatic registration" agencies complete text changes: July 1 (estimate)
- 9. Receive printed voter registration applications: Minimum 6 weeks for production and delivery. The estimated shipping date is July 18.

## **MDVOTERS**

The 8.5 release was implemented on May 20. This release included enhancements to the ballot export file and various helpdesk tickets. During the MDVOTERS downtime for the release server, enhancements were completed to assist with the local boards with processing voter notification cards triggered by the redistricting process. The next release is scheduled for June 10, and the release will address the election judge module and high speed mail sorter enhancements.

#### **MDVOTERS Audits**

Monthly audits of voter registration data continue to verify compliance with federal and State laws governing voter registration. The monthly audits include review of the local boards of elections' processing of Electronic Registration Information Center (ERIC) reports, Department of Health (DHMH) death records, Administrative Office of the Courts (AOC) felony records, and the processing of overall voter registration records. Follow up is conducted with the local boards to ensure all corrections are completed and to address any training issues. On a monthly basis, a minimum of 144 audits are conducted.

## Electronic Registration Information Center (ERIC) - Membership

ERIC's membership now has 31 states plus the District of Columbia. For more information on ERIC, please visit <a href="https://ericstates.org/">https://ericstates.org/</a>.

## **ERIC Files**

We are now receiving ERIC data on a monthly basis. On even months (February, April, etc), we receive the In-State Updates, Cross-State, and NCOA (National Change of Address) reports for processing. Odd months bring us the In-State Duplicate and Social Security Administration Death files for processing. Now that we are

within 90 days prior to an election and prohibited from sending list maintenance mailings, we will receive the In-State Duplicate and SSA Death files on a monthly basis.

## Motor Vehicle Administration (MVA) Transactions

During April, MVA collected the following voter registration transactions:

New Registration - 10,522 Residential Address Changes - 15,611

Last Name Changes - 2,254 Political Party Changes - 2,970

During May, MVA collected the following voter registration transactions:

New Registration - 11,349 Residential Address Changes - 18,510

Last Name Changes - 2,810 Political Party - 3,646

## Non-Citizen Registration and Voting

From April 20, 2022 to May 30, 2022, 15 voter records were canceled due to these voters not being U.S. citizens. 5 voters have voting history. SBE will review these records prior to submitting them to the Office of the State Prosecutor.

## Candidacy and Campaign Finance (CCF) Division

## **Candidacy**

The deadline for Petition and non-principal political party candidates to file a Declaration of Intent for candidacy is July 5, 2022 at 5 pm. Filings are still by appointment.

## Campaign Finance

## State Public Financing Program

In order to qualify for a public contribution, the candidate must raise \$120,000 from 1,500 Maryland residents. The certified gubernatorial ticket has qualified for a total of \$798,527.68 in public funds and received \$78,672 in public funds in May. One gubernatorial ticket filed a notice of intent but failed to qualify by the deadline.

## County Public Financing Programs

Montgomery County: There are 19 certified candidates in the program. Eight additional candidates have filed a notice of intent to participate. The certificate deadline to qualify for a public contribution is June 4. The program has disbursed \$175,475 in April and \$147,881 in May with an aggregate disbursement total of \$2,256,071.

Howard County: There are three certified candidates in the program. Three more candidates filed a notice of intent to participate in the program. The deadline to qualify for a public contribution is June 4. As of May 17, the program has disbursed a total of \$561,553.49.

## Website Activity

In April, the MD Campaign Reporting Information System (MD CRIS) website was visited by 339,042 individuals for an average of 11,301per day. Additionally, it had 2,247,288 hits. Each viewer looked at an average of approximately 5.17 page views per day. The Business Contribution Disclosure System (BCDS) website had 830,584 hits, with 58,420 visitors with an average of nearly 13.6 page views per day.

## **Voting Systems**

## New Electronic Pollbook

Work on implementing the new electronic pollbooks continues. We are simultaneously in the Project Initiation and Planning and the Analysis and Design phases. The project initiation and planning phase is on schedule for completion in the second quarter of 2022, and the analysis and design phase is on schedule for completion in the third quarter of 2022.

## **Voting System Replacement Project**

The current voting system lease ends March 2023, and there is one option remaining. If exercised, the final option ends March 2025. We are currently gathering information about current and future voting system solutions and are on schedule to complete this phase by the third quarter of 2022.

## Ballot Drop Box Delivery

The delivery of 280 state-owned ballot drop boxes for the upcoming 2022 Gubernatorial Primary election have been scheduled to begin on Monday, June 6, 2022. Six days have been allotted to complete the delivery of the ballot drop boxes and all units are expected to be in place by Monday, June 13, 2022.

## Logic and Accuracy Testing (L&A)

Logic and Accuracy testing of the voting equipment for the upcoming Gubernatorial Primary election has begun. All equipment to be deployed for Early Voting, Election Day or for the Canvassing of mail-in ballots will be tested by the local boards of elections. L&A testing on voting equipment to be deployed for Early Voting must be completed by July 5, 2022. The L&A testing of voting equipment to be deployed for Election Day will be completed statewide by July 9, 2022.

## **Project Management Office (PMO)**

## **Inventory Management**

The SBE FY22 Inventory Auditing of equipment and supplies statewide started on February

1. Currently, between SBE and the local boards, 94.92% of the inventory has been audited, with an end date for all the inventory auditing on June 31, 2022.

## **Central Warehouse**

The Central Warehouse team is busy working on a number of tasks related to the upcoming election with the receiving and shipping out of equipment and supplies.

## **Document Management**

We issued a Request for Information (RFI) for responses from document management system vendors. The closing date for the responses was April 29. We received 17 responses to the RFI and are completing the review process. One of the next steps will be to generate the requirements for the document management system Request for Proposals (RFP).

Working on the agency's records retention requirements with a focus on the submission of documents to the State Archives for permanent storage.

## **DECLARATION OF QUORUM PRESENT**

Mr. Voelp called the meeting to order at 10:33 am. He noted that Severn Miller was not in attendance but declared that a quorum was still present.

#### ADDITIONS TO THE AGENDA

There were no additions to the agenda, but Mr. Voelp thanked the local boards of elections for their hard work so far this election season, particularly regarding the changes required due to the change in the election date.

#### APPROVAL OF REPLACEMENT EARLY VOTING CENTER- FREDERICK COUNTY

Ms. Dorsey presented a request for approval from the Frederick County Board of Elections to replace one early voting center – the Middletown Volunteer Fire Department with Middletown Primary School – for the primary election only. SBE recommended approving the request.

Ms. Woodward made a motion to approve the request for a replacement early voting center, as presented by Ms. Dorsey, for Frederick County. Mr. Funn seconded the motion. The motion passed unanimously.

### APPROVAL OF DELAYED POLLING PLACE ASSIGNMENTS OR CHANGES

Ms. Duncan presented for approval polling place assignments or changes from the Anne Arundel, Baltimore, Frederick, Garrett, Harford, Howard, Montgomery, Prince George's, Wicomico, and Worcester Boards of Elections. She explained that local boards can change polling places up until 13 weeks before the election. That deadline was April 18, 2022 for the July 19 Primary Election. Because of already-planned summer activities, many polling places are not able to host voting on July 19.

In response to a question regarding how to proceed, Mr. Funn stated that he supported voting on all the changes at one time. Mr. Williams and Ms. Woodward concurred with Mr. Funn.

Mr. Funn made a motion to approve the requests for the polling place assignments or changes as presented in the meeting materials by Ms. Duncan for Anne Arundel, Baltimore, Frederick, Garrett, Harford, Howard, Montgomery, Prince George's, Wicomico, and Worcester Counties. Mr. Williams seconded the motion. The motion passed unanimously.

#### **SCHEDULE NEXT MEETING**

The next meeting is scheduled for Thursday, June 2, 2022 at 2 p.m.

## **ADJOURNMENT**

Mr. Funn made a motion to adjourn the meeting. Ms. Woodward seconded the motion, and it passed unanimously. The meeting adjourned at 10:43 am.

## ASSISTANT ATTORNEY GENERAL'S REPORT

June 2, 2022

- 1. WinRed, Inc. v. Ellison, et al., No. 21-cv-1575 (D. Minn.). On July 7, 2021, WinRed, Inc. – a federal PAC created to assist Republican Party candidates – filed a lawsuit against the Attorneys General of Connecticut, New York, Maryland, and Minnesota (the "State AGs"), seeking a declaration that State consumer protection statutes and regulations are preempted by federal law, to the extent that these State laws are being enforced to regulate the use of pre-checked recurring contribution boxes for solicitations for federal offices. WinRed had received letters from the defendants requesting information and documents regarding its use of pre-checked boxes in that context. (It is now public that ActBlue – the PAC formed to assist Democratic Party candidates – has received a similar request from the same State AGs, but has not joined this lawsuit.) On July 27, 2021, WinRed filed a motion for preliminary injunction against enforcement of subpoenas served by the State AGs. On July 29, 2021, the State AGs moved to dismiss the complaint. Oral argument on both motions took place on November 2, 2021. On January 26, 2022, the Court issued an order denying Plaintiff's motion for preliminary injunction and granting the defendants' motion to dismiss, and dismissed the Complaint. WinRed has appealed the dismissal to the U.S. Court of Appeals for the Eighth Circuit. On March 25, 2022, WinRed filed its opening brief. The Appellees' response was filed in late April. WinRed filed its reply brief on May 23, 2022. The Court is in the process of being scheduled for oral argument.
- 2. Conners v. State of Maryland, et al., No. C-02-CV-21-001282 (Cir. Ct. A.A. Cnty.). On September 23, 2021, the Plaintiff filed a lawsuit challenging the SBE's disclosure of personalized voter information on lists of registered voters without obtaining voters' consent. She alleges that SBE's practices of (i) disclosing information beyond just the names of voters on the voter list, (ii) disclosing the voter list to non-Maryland registered voters, (iii) transmitting the voter list to individuals or organizations who do not swear the oath that the list will only be used for electoral purposes, (iv) failing to ensure that the purpose for which the list is intended to be used by the applicant comports with that requirement, and (v) allowing only some voters to participate in the voter confidentiality program, violates various State and federal laws and constitutional provisions. The plaintiff is seeking, among other things, damages in the amount of \$400,000 for each instance her voter information was disclosed on a voter list transmitted to an applicant, and seeks injunctive relief in the form of an order forbidding SBE from disclosing voter information without the affirmative consent of the voter and requiring

SBE to issue new voter ID numbers to every Maryland registered voter. The State of Maryland, the State Administrator, and the Governor are named as defendants in the case.

Meanwhile, on November 8, 2021, the Defendants filed a motion to dismiss the Complaint. On November 23, 2021, Plaintiff filed an opposition to the motion to dismiss. The motion to dismiss was heard on February 14, 2022. On March 10, 2022, the Circuit Court issued an opinion and order dismissing the Complaint. Ms. Conners did not appeal.

- 3. Baltimore Cnty. Branch of the NAACP, et al. v. Baltimore Cnty., Md., et al., No. 1:21-cv-03232 (D. Md.). On December 21, 2021, the Baltimore County Branch of the NAACP, the League of Women Voters, Common Cause of Maryland, and several individual plaintiffs filed a lawsuit challenging the Baltimore County redistricting map for county council districts, on the ground that it violated section 2 of the Voting Rights Act. Baltimore County, the individual members of the Baltimore County Council, and the Baltimore County Board of Elections were named as defendants. (The individual County Council members have since been dismissed from the case.) On January 19, 2022, the plaintiffs filed a motion for preliminary injunction, and the court entered an order setting a hearing for February 15, 2022 on the plaintiffs' motion. On February 22. 2022, the court ruled in favor of the plaintiffs, and ordered Baltimore County to produce a compliant map by March 9, 2022. On March 9, 2022, Baltimore County filed its proposed remedial map. The Court has asked the plaintiffs to respond to the filing by 5 pm today, and will hold a conference with the parties on March 11, 2022 to discuss further proceedings. On March 25, 2022, the Court approved the remedial map proposed by Baltimore County. On May 9, 2022, after reviewing status reports from the parties, the Court dismissed the matter without prejudice, to allow the plaintiffs to bring a challenge to the county map after the July 19, 2022 election if they determine that a challenge is warranted, and to file a motion to attorneys' fees by June 6, 2022.
- 4. *In the Matter of Seth Wilson*, No. C-02-CV-22-000078 (Cir. Ct. A.A. Cnty.). On January 14, 2022, Seth Wilson, the Chairman of the Washington County Republican Party Central Committee, filed a petition for administrative mandamus of the determination and approval, respectively, by the Washington County Board of Elections and SBE, of the locations for early voting centers in Washington County for the 2022 elections. On January 19, 2022, the agencies were provided notice of the petition for administrative mandamus by the Clerk of the court. On March 22, 2022, the agencies filed administrative records. Mr. Wilson has filed his memorandum of law in support of his petition. The State and Local Boards have filed answering memoranda. Mr. Wilson

will likely be filing a reply memorandum within the next two weeks. A hearing on the petition has been scheduled for August 15, 2022.

- 5. Brian Marron v. Linda Lamone, No. C-02-CV-22-000795 (Cir. Ct. A.A. Cnty.). On May 9, 2020, Brian Marron, a registered voter, filed a lawsuit against Linda Lamone and Daniel Cox. Mr. Marron claimed that Mr. Cox was ineligible to run for Governor because of his alleged involvement in the events at the Capitol on January 6, 2021. Ms. Lamone filed a motion to dismiss or for summary judgment, and requested an expedited hearing. After briefing the motion and argument on May 20, 2022, the Court granted the motion to dismiss because it was untimely and barred by laches. Mr. Marron did not appeal.
- 6. Paul Corderman v. Shawn Perry, No. C-21-CV-22-000226 (Cir. Ct. Wash. Cnty.). On March 16, 2022, Senator Paul Corderman sued Shawn Perry, the Maryland State Board of Elections, and the Washington County Board of Elections. Senator Corderman was challenging Mr. Perry's residency and alleged that his name should not appear on the ballot. After a hearing on May 26, 2022, the Court concluded that Mr. Perry established his residency before the deadline to run for office and his name did not need to be removed from the ballot.

H. Deep Fake.

- (1) In this paragraph "Deep Fake" means an audio or video recording that appears to constitute a true recording of an action, a sound, a vocalization, or an image, but:
  - (a) Did not occur in the manner presented by the recording in reality; and
  - (b) Was generated with the assistance of computer software to create apparently authentic images, vocalizations, or recordings.
- (2) A deep fake created, used, paid or authorized by a political committee or its agent for the purpose of promoting or opposing a candidate, a prospective candidate, or the approval or rejection of a question is campaign material as defined under Election Law Article, §1-101(k), Annotated Code of Maryland.
- (3) A political committee that creates, uses, pays or authorizes the creation, distribution, publication, or use of a deep fake as or included in campaign material, shall include:
  - (a) The authority line required under Election Law Article, §13-401(a)(1),
    Annotated Code of Maryland, within the publication or distribution of the deep fake; and
  - (b) In a clear and conspicuous manner at the beginning and the end of the part off the campaign material containing the deep fake that the content or substance of what is being presented does not reflect a true recording of an action, sound or image that occurred in reality.

#### I. Text Message.

(1) A text message created, used, paid or authorized by a political committee or its agent and sent to a potential voter or donor for the purpose of promoting or opposing a candidate, a prospective candidate, or the approval or rejection of a question is campaign material as defined under Election Law Article, §1-101(k), Annotated Code of Maryland.

- (2) A political committee that creates, uses, pays or authorizes the creation, distribution, publication, or use of a text message constituting campaign material under paragraph I(1) of this Regulation shall include the authority line required under Election Law Article, §13-401(a)(1), Annotated Code of Maryland, within the text message.
- (3) If the character limit of a text message constituting campaign material described in paragraph I(1) of this Regulation is not sufficient to include the authority line information required under Election Law Article, §13-401(a), Annotated Code of Maryland, in a legible manner, the political committee is in compliance with the authority line requirement under Election Law Article, §13-401(a), Annotated Code of Maryland if a second text message that prominently displays the authority line information required under Election Law Article, §13-401(a), Annotated Code of Maryland, is immediately sent to the same number to which the text message constituting campaign material described in paragraph I(1) of this Regulation was sent.

#### .01 Definitions

- B. Terms Defined.
  - (1) "Deep fake" has the meaning stated in COMAR 33.13.07.02H(1).
  - (2) "Political convention" means the act of a political party or central committee of the political party to select, nominate, or elect:
    - [(1)](a) A replacement candidate to the ballot pursuant to Election Law Article, Title 5, Subtitles 9 and 10, Annotated Code of Maryland;
    - [(2)](b) A member to the central committee;
    - [(3)](c) A person for appointment to fill a vacancy in accordance with Article III, Section 13, of the Maryland Constitution; or
    - [(4)](d) A candidate for the general election.

#### .02 Prohibited Acts

(E) Deep Fake. A person may not willfully or knowingly influence or attempt to influence a voter's decision to go to the polls or to cast a vote by publishing, distributing, or disseminating material constituting or containing a deep fake within 90 days before an election without meeting the same requirements imposed on political committees under COMAR 33.13.07.02H.

Except as provided in §B of this Regulation, [T] the State Board shall assess a late filing fee for a failure to file the statement of contributions required under Election Law Article, §14-104, Annotated Code of Maryland, [of \$10 for each day or part of a day that the statement of contributions is overdue] in the same method and manner as prescribed by Election Law Article, §13-331(b), Annotated Code of Maryland.

B. Maximum Fee. The maximum fee assessed under §A of this regulation is \$[500] 1,000.

#### .07 Campaign Contribution Receipts

A. Receipts. By the next deadline for filing a campaign finance report after receiving a contribution specified in paragraph (2) of this subsection, a treasurer shall issue a campaign contribution receipt.

- B. Required Contents. The receipt issued by the treasurer shall include:
  - (1) The name of the contributor;
  - (2) The address of the contributor;
  - (3) The date of the contribution;
  - (4) The transaction method of the contribution;
  - (5) The amount of contribution;
  - (6) The aggregate amount of contributions made by the contributor to the political committee as of the date of the contribution;
  - (7) The name of the campaign finance report that the contribution was disclosed on; and
  - (8) Language regarding the contribution limits for an election cycle.

### Title 33 STATE BOARD OF ELECTIONS Subtitle 13 CAMPAIGN FINANCING

### **Chapter 14 Public Financing**

Authority: Election Law Article, §§2-102(b)(4) and 13-505(b)(7), Annotated Code of Maryland

### .07 Coordinated In-Kind Contributions.

A. In General. Coordinated expenditures by a State central committee of a political party with a candidate, or by the local central committee of a political party with a candidate who will appear only on the ballot in the county of the local central committee, are considered coordinated in-kind contributions.

### B. Limits.

- (1) A State central committee may not make a coordinated in-kind contribution in excess of \$10,000 per election to a candidate for elective office of county government participating in public financing in that election.
- (2) A local central committee may not make a coordinated in-kind contribution in excess of \$10,000 per election to a candidate for elective office of county government participating in public financing in that election.
- C. Sources of Funds. Any monies spent by a central committee on a coordinated in-kind contribution to a candidate for elective office of county government participating in public financing must be raised from permissible sources for that candidate within the reporting period for which the coordinated in-kind contribution was made.
- D. Prohibitions. Except as provided in this regulation, all other coordinated in-kind contributions from other political committees are prohibited for a candidate for elective office of county government participating in public financing.
- E. Disclosure. All coordinated in-kind contributions for candidates for elective office of county government participating in public financing are subject to the reporting requirements of COMAR 33.13.18.02.

### .08 Electronic Signatures.

### A. Definitions.

- (1) "Contribution card" has the meaning stated in Election Law Article, § 15-102(c), Annotated Code of Maryland.
- (2) "Electronic signature" has the meaning stated in Election Law Article, § 1-101(y), Annotated Code of Maryland.

- B. Electronic signatures. An individual may place an electronic signature on the contribution card or the receipt of the contribution to the candidate for elective office of county government participating in public financing.
- C. Electronic signatures—Process. An electronic signature:
- (1) Shall be affixed or entered directly by the signer onto an electronic copy of the contribution card; and
- (2) May not be pre-populated or otherwise entered by the signer by way of a check box, radio button, drop-down list, or other similar device, but instead must be entered or affixed by the signer by making affirmative marks into an empty field.
- D. Electronic signatures—Restrictions. An individual may not sign a contribution card with an electronic signature unless that individual affirms that the contribution:
  - (1) Is being made from personal funds of the individual;
  - (2) Is not being reimbursed or is not intended to be reimbursed in any manner;
  - (3) Is not being made as a loan; and
- (4) If applicable, in the case of a credit card contribution, is made from a personal credit card account of the individual that has no corporate or business affiliation.

### .09 Transfers.

- A. Prohibitions. Transfers from a publicly financed candidate committee to any other political committee are prohibited.
- B. Voter Access Service. The purchase of the voter file access service from the State central committee is not considered a transfer and is a permissible expenditure.

Re: Petition for Declaratory Ruling

Dear Mr. Gluck:

On February 22, 2002, the State Board of Elections ("the State Board") received your petition for a declaratory ruling ("the Petition") pursuant to COMAR 33.01.02 regarding seeking to file a declaration of intent for multiple public offices simultaneously. On April 27, 2022, the State Board considered your Petition and decided to issue a written declaratory ruling as requested.

According to COMAR 33.01.02.01 the purpose of a declaratory ruling is for a petitioner to know how the State Board would apply a regulation, order or a statute to any person or entity. The issue presented is whether an individual may seek the nomination of a non-principal political party for multiple public offices simultaneously.

In order to appear on the general election ballot as a candidate for public office from a non-principal political party, the candidate shall file a declaration of intent no later than the first Monday in July. This step officially makes the individual a declared candidate and the candidate must have established an authorized candidate campaign committee. See Election Law Article §13-202(c). The list of candidates who filed a declaration of intent may seek the nomination from the political party. The political party may only nominate an individual to appear on the ballot in the general election if that individual has filed a declaration of intent.

Pursuant to Election Law Article §5-204(a), an individual simultaneously may not be a candidate for more than one public office. An individual's name may not be placed on the ballot and submitted to the voters unless the individual complies with the requirements of Title 5 of the Election Law Article. See Election Law Article §5-101(b). The act of filing a declaration of intent makes the petitioner a candidate for public office. Therefore, you may only seek the nomination for one public office.

Accordingly, based upon the facts and issues presented, the State Board decided that you may not file declarations of intent for multiple public offices.

On March 7, 2022, the State Board of Elections ("the State Board") received your petition for declaratory ruling regarding the discrepancies on election boundaries under Election Law Article §4-103(a).

According to COMAR 33.01.02.01, the purpose of a declaratory ruling is for a petitioner to know how the State Board would apply a regulation, order or a statute to any person or entity. The issue presented is whether an approved redistricting map supersedes the text of the redistricting legislation if a discrepancy is discovered.

The petition seeks a declaration on an issue that is not a State Board regulation, order or a statute that the State Board enforces but on the implementation of a new redistricting election boundaries. Therefore, the declaratory ruling process is an incorrect venue for the action sought. Accordingly, based upon the facts and issues presented, the State Board has decided not to issue a declaratory ruling on the matter.

At the next board meeting, I will propose changes to the following COMAR provision<sup>1</sup> (see enclosure):

- 33. 13 -Campaign Financing
  - .07 (Authority Line Requirements, Electronic Media)
    - .02 (Requirements)
  - .14 (Public Financing)
    - .07 (Coordinated In-kind Contributions)
    - .08 (Electronic Signatures)
    - .09 (*Transfers*)
- 33.18 Violations
  - .02 (Prohibited Acts)
- 33.20- Disclosure of Person Doing Public Business
  - .08 (Sanctions)

### **Campaign Financing (Subtitle 13)**

### .07 Authority Line Requirements, Electronic Media

The proposed regulation modifies the authority line requirements for the use of deep fake video and audio recordings and the sending of text messages by a political committee. The proposed regulations define what constitutes a deep fake audio and video recording. Moreover, it modifies the authority line requirements to include an additional disclaimer at the beginning and end of the recording that the audio or video recording did not occur in reality. Additionally, the proposed regulation requires a political committee that disseminates text messages to individuals but the text message service limits the number of characters in the text to immediately follow the text message with a text message including the authority line.

### .14 (Public Financing)

The proposed regulations allow for central committees to make coordinated in-kind contributions to county publicly financed candidates. The proposed regulations set limits and resists the source of the funding consistent with the enabling legislation and county programs.

### **Violations (Subtitle 18)**

### .02 Prohibited Acts

The proposed regulations require a person to place the same disclaimer requirements on a deep fake recording attempting to influence a voter's decision going to the polls or casting a vote within 90 days of the election.

### **Disclosure of Person doing Public Business (Subtitle 20)**

### .08 Sanctions

The proposed regulations update the late fee penalties to match the late fee fine structure for political committees. In 2019, the General Assembly changed the penalties for political committee to a maximum penalty of \$1,000. The law governing the contribution disclosure statement for persons doing public business requires that penalties for late filings are identical to political committees.

### Title 33 State Board of Elections Subtitle 11 Absentee Ballots Chapter 03 Issuance and Return

Authority: Election Law Article, §§2-102(b)(4), 2-202(b), 2-305, 9-303, 9-305, 9-306, 9-310, 11-301, 11-302, and 11-304, Annotated Code of Maryland

### .06 Return of Ballot.

- A. B. (text unchanged)
- C. Ballots Returned Without a Signed Oath.
- (1) Except as provided in §C(3) of this regulation, if an absentee ballot is timely received but the voter did not sign the required oath, the election director shall:
  - (a) [Promptly] As soon as practicable but not later than three business days after the election director determines that the voter failed to sign the oath, notify the voter that the voter did not sign the oath; and
  - (b) Explain how the voter can provide a signed oath and when the signed oath must be received for the voter's ballot to be accepted.
  - (2) (3) (text unchanged)
  - (4) A voter may provide a signature by email, mail, or in person visit to the local board.

### D. - G. (text unchanged)

**Explanation:** Pending Governor's signature or the legislation becoming effective without signature, <u>HB</u> 862 and <u>SB 163</u> (2022) require the local boards to contact voters who returned a mail-in ballot but did not sign the oath. The State Board previously adopted regulations requiring the same, but HB 863 and SB 163 included a different timeline for contacting voters and defined the ways voters may provide a signature. The proposed changes to 33.11.03.06C align the regulation with the two bills.

### Title 33 STATE BOARD OF ELECTIONS Subtitle 15 PRECINCTS, POLLING PLACES, AND FACILITIES Chapter 03 Polling Places

Authority: Criminal Procedure Article, §11-722; Election Law Article, §§2-102(b)(4), [and] 2-202(b), and §10-101(c); Annotated Code of Maryland

### .03 Reassignments — Spouse or Helper of Elderly Voter or Voter with a Disability.

A. (text unchanged)

B. Right to Reassignment. A voter's spouse or helper may be reassigned to the voter's polling place if the spouse or helper is registered to vote in the same county as the voter and the voter's polling place will have available *a ballot with the same content as* the spouse's or helper's ballot [style].

C. (text unchanged)

D. Issuance of Ballot. Any ballot issued to a spouse or helper under this regulation shall *have the same content* [be identical to] *as* the ballot used in the polling place originally assigned to the spouse or helper.

### .04 Reassignments — Religious Objections.

- A. B. (text unchanged)
- C. Duties of Local Board. On receipt of the request, the local board shall either:
- (1) Assign the voter to a polling place in the voter's county that does not conflict with the voter's bona fide religious beliefs and practices and has the same ballot [style] *content* as the *ballot for the* polling place originally assigned to the voter; or
  - (2) (text unchanged)
- D. Issuance of Ballot. Any ballot issued to a voter under this regulation shall *have the same content* [be identical to] *as* the ballot used in the polling place originally assigned to the voter.

**Explanation for .03 & .04**: Every precinct has its own ballot style. As a result, the reassignment process must be based on whether there is another polling place with the same ballot content. The proposed changes to Regulations .03 and .04 reflect the change from "ballot style" to the same "ballot content."

### [.07 Reassignments — Religious Objections.

A. In General. If entry into the polling place assigned to a voter conflicts with the voter's bona fide religious beliefs and practices, the voter may request a reassignment by the local board.

- B. Procedure. The request for reassignment:
  - (1) Shall be made on the form that the State Board prescribes; and
  - (2) May be made at any time before the close of registration.
- C. Duties of Local Board. On receipt of the request, the local board shall either:
- (1) Assign the voter to a polling place in the voter's county that does not conflict with the voter's bona fide religious beliefs and practices and has the same ballot style as the polling place originally assigned to the voter; or
  - (2) Issue the voter an absentee ballot in accordance with procedures established under:
    - (a) Election Law Article, Annotated Code of Maryland; and
  - (b) This title.
- D. Issuance of Ballot. Any ballot issued to a voter under this regulation shall be identical to the ballot used in the polling place originally assigned to the voter.]

### .07 Polling Place - Alcoholic Beverage License

A. In General. A local board may use a building or part of a building that is owned, occupied, or partially occupied by an establishment that holds an alcoholic beverages license as a polling place.

B. Selection Factors. A local board shall:

- (1) Prioritize the placement of polling locations in buildings that are not owned, occupied, or partially occupied by an establishment that holds an alcoholic beverages license prior to the selection of a building; and
  - (2) Make and approve a written agreement with the facility to ensure that:
  - (a) Public activities involving businesses and alcoholic sales do not interfere with voting activities; and
    - (b) Alcoholic beverages are not sold or consumed within the electioneering boundaries.

**Explanation**: The current text in Regulation .07 is a duplicate of Regulation .04 and can therefore be repealed. The new Regulation .07 is required by Chapters 191 and 192 (2022) (SB 907 & HB 328).

We will recommend that the repeal and new regulation be adopted as emergency changes and the regular adoption process. The new language for Regulation .07 is needed for the 2022 Primary Election.

### Article 1 - Adoption of Bylaws Generally

### Section 1.1 - Definitions

- A. "Administrator" means the State Administrator as defined under  $\S1-101(qq)$  of the Election Law Article.
- B. "Absence" means a duly appointed member is not present at or able to take part in a meeting.
- C. "Member" means a member of the Bboard, regardless of whether the member has been duly confirmed by the Maryland Senate.
- D. "Vacancy" means a member was removed, died, or resigned from the board.

### Section 1.2 - Purpose

These bylaws, adopted by the members of the Maryland State Board of Elections, provide the rules of governance for the board during the conduct of all duties assigned under State and federal laws and regulations. Further, these bylaws set a standard of personal conduct for members of the board requiring them to conduct themselves in accordance with high ethical standards in order to ensure the public that members are independent of partisan pressures and conflicting interests.

### Section 1.3 - Enactment

- A. These bylaws shall be approved by a supermajority vote of the full board.
- B. These bylaws are effective and binding on all <u>boardBoard</u> members as evidenced by each member signing this document.
- C. When a new member is appointed to fill a vacancy, the new member must sign the bylaws.
- D. In order to amend the bylaws, a member must make a motion and present the amendment during a regularly scheduled meeting of the <a href="https://board.board.">boardBoard</a>. The motion to amend the bylaws must be approved by a supermajority vote of the full <a href="https://board.board.board.">boardBoard</a> at the next regularly scheduled meeting of the <a href="https://board.
- E. The bylaws shall be reviewed by the members of the <u>bBeardBoard</u> on an annual basis at the first meeting of the calendar year. Members may propose changes to the bylaws at that time. If the bylaws are amended, they will be voted and approved as provided by subsection A above.
- F. A copy of the approved bylaws and any amendments shall be posted on the SBE website.

### Article 2 - Organization of the Board

### Section 2.1 - New Members

New members must be sworn in by a Clerk of the Circuit Court of Maryland within 30 days of receiving the commission of appointment from the Governor. They must be either sworn in by the Clerk of the Circuit Court of the county in which they reside or, if sworn in another county, must file their commission with the Clerk of the Circuit Court in the county in which they reside.

### Section 2.2 - Officers

- A. As required by § 2-102 of the Election Law Article, not later than August 1<sup>st</sup> of each year, the <a href="beardBoard">beardBoard</a> shall elect by a supermajority vote a member to serve as chairman. The duties of the chairman include:
  - 1. Running the board meetings and setting agendas;
  - $2. \ \ Serving \ as \ the \ primary \ \frac{board}{board} \ member \ spokes person \ for \ media \ inquiries; \ and$
  - 3. Acting as the <a href="heard">board</a>'s primary point of contact for the <a href="heart-administrator">administrator</a>. Acting as the <a href="heart-administrator">board</a> Board's primary point of contact for the <a href="heart-administrator">administrator</a>.
- B. At the same time the chairman is elected, the <a href="board-Board">board-Board</a> shall also elect by a supermajority vote a member to serve as a vice-chairman. The vice-chairman shall not be a member of the same party as the chairman. The vice-chairman shall fulfill the duties of the chairman if the chairman is absent or unable to carry out the assigned duties.

### Article 3 - Meetings

### Section 3.1 - Time and Location

- A. Regular meetings. The Maryland State Board of Elections shall meet every month on the fourth Thursday at 2:00PM.
- B. Location. Unless circumstances dictate otherwise, board meetings will be held in the election office located at 151 West Street, Suite 200, Annapolis, Maryland.
- C. Public Notice. Except as provided in E of this section, public notice of regular meetings must be provided for at least one week prior to the meeting. Information on the SBE website and public display of the meeting agenda constitute public notice for purposes of this section.
- D. Cancellation of a regular meeting. The chairman may cancel a regular meeting of the boardBoard. Notice of cancellation must be given at least one week prior to the meeting.
- E. Special Meetings. The chairman of the board may call a special meeting. However, no votes may be taken at a special meeting unless three days prior notice has been given to all members, staff and the public.
- F. Immediate Action. If the chairman determines that an issue needs immediate beard Board action that cannot wait until the next regularly scheduled meeting, the chairman may direct staff to poll the members to obtain their vote on the issue.

### Section 3.2 - Rules of Order

### A. Quorum

- 1. A quorum must be present to conduct official business of the board Board.
- 2. A quorum of the board Board of elections shall consist of a majority of the membership of the boardBoard.
- 3. In the event of a vacancy on the <a href="board">board</a>, a quorum shall consist of a majority of members currently serving on the boardBoard.
- 4. There shall be no effect on the quorum when a member of the board Board abstains or declines to vote or if a member is disqualified from participating under section 4.3 of these by-laws.
- B. Public participation at a meeting must be pre-scheduled and pre-approved by the chairman. Each bBoard Board member shall receive notice of all requests for public participation. The chairman may exercise discretion in determining whether to allow participation that has not been pre-scheduled and pre-approved.
- C. The boardBoard, with the advice of counsel, shall follow the requirements of the Open Meetings Act as specified under Title 3 of the General Provisions Article1.

### Section 3.3 - Meeting Agenda

- A. Each **board** meeting shall include, at a minimum, the following agenda items:
  - 1. Declaration of Quorum Present
  - 2. Approval of Prior Meeting Minutes
  - 3. Additions to the Agenda
  - 4. Administrator's Report
  - 5. Assistant Attorney General's Report
  - 6. Old Business
  - 7. New Business
  - 8. Confirmation of Next Meeting

- B. Additional items may be added to the agenda in advance of the meeting at the discretion of the chairman.
- C. The administrator Administrator shall provide the agenda to the members and publicly post the agenda at least one week prior the meeting.
- D. Prior to each meeting, the <a href="mailto:administrator">administrator</a> shall submit to the <a href="mailto:board-Board">board-Board</a> a written report of the activities of the office and all significant agency-related events since the last meeting. The report shall include information on personnel changes, meetings attended, significant correspondence received, voter registration activities, voting system activities, candidate filings, precinct and polling issues, and other projects or initiatives undertaken by the office. An oral summary of the written report shall be provided at each <a href="mailto:board-Board">board-Board</a> meeting.
- E. Minutes
  - 1. Minutes shall be prepared by the administrator Administrator pursuant to SBE's *Guidelines for Conducting Meetings and Writing Minutes*<sup>2</sup>.
  - 2. Closed meeting minutes shall include a summary of the meeting, the individuals in attendance, and the actions taken. The closed meeting minutes may be:
    - a. Included in the open meeting minutes; or
    - b. In a separate sealed document, provided that a summary of the closed meeting is provided in the open meeting minutes.
  - 3. If the <a href="mailto:administrator">administrator</a> does not attend the closed meeting, the assistant attorney general or one of the members shall be responsible for preparing the closed meeting summary and minutes.
  - 4. Meeting minutes shall be prepared and presented to all <a href="board-Board">board-Board</a> members within <a href="mailto:5">5</a> five business days after the meeting. The authority to approve the meeting minutes is delegated to the chairman. The chairman shall approve the minutes after the <a href="mailto:board-Board">board-Board</a> members have had two full business days to review and comment on the minutes.
  - 5. The administrator Administrator shall post the approved open meeting minutes on the SBE website within 4-one business day of the chairman's approval.

### Article 4 - Rules of Conduct

### Section 4.1 - Attendance

- A. As provided under § 8-501 of the State Government Article, a member of the <a href="boardBoard">boardBoard</a> who fails to attend at least 50% of the meetings of the <a href="boardBoard">boardBoard</a> during any consecutive 12-month period shall be considered to have resigned.
- B. Not later than January  $15^{\rm th}$  of the year following the end of the 12-month period, the chairman shall forward to the Governor:
  - 1. The name of the member considered to have resigned; and
  - 2. A statement describing the member's history of attendance during the period.
- C. In the case where the chairman fails to attend meetings, the referral to the Governor shall be made by the vice-chairman.

### **Section 4.2 - Political Activity**

- A. Statutory requirements. The members shall abide by the restrictions to political activities provided under  $\S$  2-301 of the Election Law Article. See Appendix 1.
- B. Additional requirements.

### Bylaws of the Maryland State Board of Elections

- 1. Members shall place their public duties ahead of partisan, political considerations.
- 2. A member may not take an active part in the campaign management of a candidate or any matter that is subject to an election under the Election Law Article.
- 3. A member may attend political events held by candidates, political parties, or ballot issue committees\_provided that the member does not publicly indicate that he or she is a member of the board Board.
- 4. A member may make campaign contributions to entities that file with the State Board of Elections provided the member discloses the contributions to the board Board 3.
- 5. A member may publicly display (including yard signs, bumper stickers, etc) support or opposition to candidates or issues on the ballot in any election for which the member will be serving on the boardBoard.
- 6. Members may wear campaign paraphernalia that shows support or opposition for or against candidates or issues on the ballot in any election for which the member will be serving on the  $\frac{\text{board}}{\text{Board}}$  provided the member does not wear the campaign paraphernalia while performing board functions or while wearing a board Board name badge.
- 7. Party Activity Members may not serve on an executive committee of the party or assume a role within the party that has decision making authority.
- 8. Petitions
  - a. A member may sign a petition.
  - b. A member may not circulate petitions.
- C. Members shall provide any required disclosure of an activity specified under subsection B at the boardBoard meeting immediately following the payment of the campaign contribution.

### Section 4.3 - Ethics

- A. Members shall follow the provisions of the Maryland Ethics laws<sup>4</sup>, including:
  - 1. Within 30 days of receiving a commission from the Governor and by April 30th each year thereafter, filinge the Financial Disclosure Statement<sup>5</sup> required under § 15-601 et seq. of the State Government Article; and
  - 2. Adhering to the prohibition against the solicitation or acceptance of gifts or honoraria as required under § 15-505 of the State Government Article.
- B. Disqualification due to Conflict of Interest
  - 1. A member shall recuse himself or herself and may not participate as to a matter if the member:
    - a. Has a relative with an interest in the matter and the member knows of the interest;
    - b. Is part of a business entity which has an interest in the matter;
    - c. Is negotiating employment or has arranged prospective employment with a business entity which has an interest in the matter;
    - d. Has a direct financial interest in the matter;
    - e. Has provided support through a contribution to or volunteering for or a candidate or petition that is the subject of the matter; or
    - Otherwise believes that participation would create a conflict of interest.

- 2. A member may seek the advice from the assistant attorney general as to the presence of a conflict of interest or other good cause for disqualification.
- 3. If a member does not voluntarily recuse himself or herself, the other <a href="heardBoard">beardBoard</a> members may disqualify that member if a supermajority determines that the member has a conflict of interest that should disqualify that member from acting on a particular matter.
- If a member recuses himself or is disqualified from participating in a matter before the boardBoard, the recusal or disqualification and the reason(s) for it shall be recorded in the meeting minutes.

### **Section 4.4 - Resignation and Vacancies**

A member who chooses to resign shall provide written notice of the resignation to:

- 1. The Governor:
- 2. The state central committee of the party with which he or she is affiliated; and
- 3. The State Administrator.

### Section 4.5 - Level of Effort

Members shall expend the time and effort necessary to ensure that they fully understand their duties and obligations as members of the State Board of Elections and generally understand important concepts in the administration of Maryland elections, such as: the process to register to vote; the purpose of provisional voting; general information about the voting systems; the <a href="mail-in voting absentee ballot-process">mail-in voting absentee ballot-process</a>; campaign finance requirements; and important election deadlines.

### Section 4.6 - Fiduciary Duty to the Board

Members have a fiduciary duty of care and loyalty to the <a href="boardBoard">boardBoard</a>. Members shall put the interests of the <a href="boardBoard">boardBoard</a> ahead of partisan interests, personal interests, or loyalties to other organizations in an effort to ensure the successful execution of the duties of the <a href="boardBoard">boardBoard</a>. Members may not share confidential or sensitive information with outside entities, including matters discussed during closed sessions of the <a href="boardBoard">boardBoard</a>.

### Article 5 - Roles and Responsibilities

### Section 5.1 - The Board

- A. The <a href="https://beard.com/beard-board-and-state-assigned">beard.com/beard-bo
- B. The <a href="beardBoard">beardBoard</a> shall attend exclusively to top-level policies and plans and shall ensure compliance with mandatory requirements. The <a href="beardBoard">beardBoard</a> shall not be involved in day-to-day activities of the election office.

### Section 5.2 - The Administrator and Staff

- A. The administratorAdministrator shall carry out all duties assigned to him or her under the Election Law Article, regulations, policies and procedures established by the boardBoard, and duties assigned or delegated by the boardBoard. (See Duties of the State Board and State Administrator).
- B. The administratorAdministrator, as the State's Chief Election Official, is responsible for all aspects of managing elections in Maryland including the day-to-day operation of the State office, implementing State election laws and regulations, and serving as a subject matter expert for the Board, the General Assembly, and other stakeholders.

### **Section 5.4 - Delegation of Duties to the Administrator**

The board Board delegates to the Administrator the duties designated in *Duties of the State Board and State Administrator* to the administrator.

### **Section 5.5 - Personnel Management**

- A. As required under § 2-202(b)(2) of the Election Law Article, the <a href="boardBoard">boardBoard</a> shall hire the <a href="administrator">administrator</a>. The <a href="boardBoard">boardBoard</a> shall follow the requirements of § 2-103(b)(7) of the Election Law Article if the <a href="boardBoard">boardBoard</a> determines that the <a href="administratorAdministrator">administrator</a> should be removed for incompetence, misconduct, or other good cause.
- B. The administrator shall hire and supervise the staff of the State Board.
  - 1. The administrator Administrator shall perform or ensure the performance of annual performance evaluations of staff.
  - 2. The administrator Administrator shall follow the requirements of the State Personnel and Pensions Article and any applicable regulations in all matters concerning leave, discipline, or termination.

### Article 6 - Miscellaneous

### Section 6.1 - Per Diem and Reimbursement for Travel and Expenses

- A. When provided for in the State budget, the budget for the <a href="boardBoard">boardBoard</a> shall include funds to pay each member per diem compensation for each day that the member is actually engaged in the discharge of official duties.
- B. The budget for the **boardBoard** shall include funds to reimburse members for expenses incurred while carrying out their duties as members.
- C. Reimbursement for an expense that was not budgeted for must be approved by the chairman prior to payment.

### Appendix 1

Election Law Article, Annotated Code of Maryland §2–301.

- (a) This section applies to:
  - (1) a member of the State Board;
  - (2) a regular or substitute member of a local board;
  - (3) the State Administrator;
- (4) an employee of the State Board or of a local board, including the election director of a board;
  - (5) counsel appointed under § 2-205 of this title; and
  - (6) an election judge.
  - (b) (1) An individual subject to this section may not, while holding the position:
- (i) hold or be a candidate for any elective public or political party office or any other office created under the Constitution or laws of this State;
- (ii) use the individual's official authority for the purpose of influencing or affecting the result of an election; or
- (iii) except as provided in paragraph (2) of this subsection, as to any candidate or any matter that is subject to an election under this article:
  - 1. be a campaign manager;
  - 2. be a treasurer or subtreasurer for a campaign finance entity; or
  - 3. take any other active part in political management or a political

campaign.

and

- (2) Notwithstanding paragraph (1)(iii) of this subsection, an election judge may engage in the activities of a political campaign, except:
  - (i) while performing official duties on election day; and
- (ii) by serving as a campaign manager for a candidate or as the treasurer for a campaign finance entity.
- (c) If the State Administrator determines that an individual is in violation of this section, the State Administrator:
  - (1) shall suspend the individual from duty until the completion of the next election;
- (2) notwithstanding any other provision of law, may make an interim appointment to ensure the orderly administration of this article.

#### Basis for the request:

In January 2021 my campaign Treasurer, James Lloyd Smith, and I filed what we thought was a close out report for my campaign, Friends of Thomas E. "Tim" Hutchins CCF ID 01012876, filing period 01/13/2021. This report was submitted on 1/20/2021 by the Treasurer. Under part 4 Page 2 of 5 of this report, the entire balance of the account, \$9168.08, reported as Total Expenditures, leaving a cash balance of \$0.00. We made disposition on the residue of the campaign account via a donation to the College of Southern Maryland. Subsequently, we advised the Bank America, Prince Frederick Md Branch to close the bank account and we also closed the PO Box associated with the campaign.

At this point the Treasurer and I assumed that we had fulfilled the requirements of the Maryland State Board of Elections and considered the matter closed. Executing all actions in good faith and undertaken to the best of our understanding thus terminating our official association as candidate and treasurer.

Calendar year 2021 soon erupted into crisis when the COVID-19 pandemic arrived in force. I contracted COVID-19, detected while on a trip to Florida, which required quarantine from the first part of February 2021 and not able to return to Maryland until May. As a result, COVID associated heart issues required timely action. Consequently, I resigned my position as a Calvert County Commissioner in June 2021, closed out my mailing address in Maryland and returned to Florida for open heart surgery and subsequent follow-on treatments throughout the remainder of 2021 and continuing on to the present time which have required three subsequent hospitalizations.

On or about February 14, 2022, I received a letter from the State Board of Elections which my daughter, who lives in Maryland near my house there, found the letter in her mail and forwarded to me. The letter was a notice from the State Board of Elections, dated January 27, 2022, as a" Fee Running Notice—Campaign Finance Due". This was

the first time that I was aware that something was amiss with the filing of January 20,2021.

Accordingly, as the candidate, I am the principal responsible for the campaign and its actions and requirements. I request a waiver for any and all penalties associated with any late reports or failure to submit a correct report, based primarily a misunderstanding and communications as to the status of the filing on January 20,2021. My personal communications were compounded by incapacitation and associated limits due to ongoing medical condition and location in another state. My former Treasurer and I converse periodically with regards to my health condition. However, there was no reason to believe we had not met the requirements of the State Board of Election.

Upon contacting the campaign Treasurer, Mr. Smith filed another Annual report as a "FINAL" on February 25, 2022. I verified this report via the MCRIS on the same day.

Further, I have personally had campaigns in Maryland at the federal, state, and local level and not encountered any problems until now. Thus, I feel it appropriate in making a plea for reconsideration in this matter.



The Board should consider the following factors in determining whether just cause exists to grant a waiver.

- 1. Administrative error of any kind on the part of the Division.
- 2. The lateness is due to extenuating circumstances, i.e. physical illness or death in the family; or
- 3. Computer problems occurred which made timely filing impossible. However, the filer still must have demonstrated a good faith effort to timely file.

Prior to the meeting please review each waiver request. Note the recommendations that you may disagree with or have questions on that you would like to discuss.

### § 14-107(c) Late Filing Fees

- (1) As provided in this subsection, the State Board may impose fees for late filing of:
  - (i) a statement required under § 14-104 of this title; or
  - (ii) an amended statement required under subsection (b) of this section.
- (2) The State Board may impose late filing fees in the same amounts and in the same manner as provided under § 13–331(a) and (b) of this article for late filing of campaign finance reports.
- (3) Late filing fees imposed under this subsection shall be distributed to the Fair Campaign Financing Fund.

Pursuant to COMAR 33.20.07.01C, the State Administrator has denied zero late fee waiver request. No Board action is required on the denials.
