SUBJECT: Waiver of late filing fees standards

Enclosed are the waiver requests, which were submitted by campaign committees that have been assessed late filing fees. The attached Waiver Request Information Page contains an overview of each committee as well as the Administrator's recommendation for Board approval on granting a waiver request.

In the past the Board has considered the following facts in determining whether just cause exists to grant a waiver.

- Administrative error of any kind on the part of the Division.
- □ The lateness is due to extenuating circumstances, i.e. physical illness or death in the family.
- □ The late report is the first late report and allows the committee to close, or contains minimal financial activity.
- □ The fee will cause undue financial hardship, if the liability of the fine is the personal responsibility of the officers.
- Computer problems occurred which made timely filing impossible. However, the filer still must have demonstrated a good faith effort to timely file.

Prior to the meeting please review each waiver request. Note the recommendations that you may disagree with or have questions on that you would like to discuss.

Pursuant to Election Law Article §13-337 (b) (3), the State Administrator has denied seven waiver request, for the month of June. No Board action is required on the denials. Late fees collected year to date for Late Fee Waivers are \$62,255.58.

I am the daughter of the late John J. Bishop, III, a former Member of the Maryland House of Delegates, and former 2014 Maryland gubernatorial candidate – the gubernatorial candidacy being the origin of the subject of this letter. My father passed away in June of last year and, since then, I have been working to wrap up his affairs – including piecing together the open matters related to his Committee to Elect John Bishop. My mother, Sally Bishop, is still the named Treasurer. The Committee has been assessed late fee penalties totaling \$3,140 for failure to timely file certain reports, of which \$1,000 is with the State Prosecutor's Office for enforcement. I write to request a waiver of all late fee penalties for failure to timely file reports.

I have completed all required reports, with the help of Lisa Hanzook, Financial Compliance Auditor with the Candidacy and Campaign Finance Division. A big thanks to Lisa for her help. In support of the waiver request, I offer first an apology for not knowing enough to understand what needed to be done to avoid the penalties. Second, to explain a bit of our situation since my father's death.

My father and mother lived together at the time of his death. My mom has not been in good health for some time, and is on a fixed income of Social Security and the remainder of my late father's State of Maryland pension. My husband and I live in Texas, and have two small children 6y and 4y this year. We both have demanding jobs. When my father passed away suddenly last year, I spent nearly a year traveling back and forth to Maryland to clean out the house and prepare it for sale. We sold the house in March of this year, and moved my mother to live with us in our home in Texas. Since then, my time is stretched among the demands of work, small kids, the administrative requirements of setting up my mother here in Texas, and shuffling to and from the many doctors' appointments needed for my mom.

I would appreciate very much consideration of waiving the late fee penalties. Should you need any additional information from me, please do not hesitate to reach out.

I'm writing to request a fee waiver for an outstanding balance for the Pre-General 1 Report that was due on August 30, 2022, for the Committee to Elect Jonathan Briggs.

I called the State Board of Elections on Friday, September 30, 2022, and spoke with Ms. Jessical Perkins about a fee running notification that me and my Treasurer received on September 30, 2022. I informed Ms. Perkins that my treasurer (who indicated in CRIS that he would like to receive email and mail notifications) had not received any notice of an upcoming report -- nor had I.

The only notification I received from the State Board of Elections was a memorandum in the mail that acknowledged receipt of, and approved, my appointment as an officer for the campaign committee. Beyond that outreach -- which arrived in mid-September -- I, nor my treasurer, had not receive any notification, such as a pre-report notification or a "green card" in the mail (which Ms. Perkins mentioned one of us should have received).

Attached to this email I have included the correspondence from my CRIS account as well as my Treasurers. Per Ms. Perkins guidance, I was informed that any correspondence that was shared with me or my Treasurer would all be listed in the "correspondence" section of CRIS. The screenshots indicate show that, beyond the "Statement of Organization" that was approved in August, we did not receive any correspondence or notification in August to alert us of an upcoming report. I also attached an image of an account that my Treasurer has served as treasurer for in the past -- he indicated that he is used to receiving a pre-report notice (like in the screenshot) -- and there is a discrepancy in the detail of information that was shared in this case. For example, there is no pre-report notification.

The only notice that we received of the Pre-General 1 Report was that we owed a fee, and that was well after the August 30 deadline. With that being said, I would like to request that the \$1,000 fee be waived due to us not being made aware in sufficient time to complete the report without incurring fees.

Finally, my statement of organization was established on August 10, 2022, so I did submit an affidavit confirming that I hadn't had any transactions between 07/04 - 08/23. I submitted that affidavit on Friday. Please let me know if there are any additional steps, or information, that I need to submit regarding the Committee Citations/Violations Outstanding Balance of \$1,000.

FINAL CLOSE OUT REPORT and REQUEST TO WAIVE FEES

This Campaign account was created in 2009 for a campaign for the House of Delegates in 2010 and again in 2014. The Campaign opened up a bank account with Chesapeake Bank (x0020). After an initial flurry of activity, the account has been mostly dormant since 2011. The Officers have filed affidavits of limited expenditures for every accounting since. The initial loan to the campaign has been forgiven a little bit at a time until it has been extinguished. Any expenditures have been modest and the only income has been from the Chairperson to prevent dormancy charges on the bank account.

Ultimately the campaign closed down the bank account in accordance with Maryland Code, Election law, Section 13-247 (1)(ii). A final check was issued to the Anne Arundel County Central Democratic Party in early 2020. The bank account was then closed.

The Officers tried to file a final accounting through the online portal but were unsuccessful. Since then, the Officers have filed Affidavits under section 13-305. They have selected the online box to make it a final account and have been rejected each time.

The online portal does not seem to have a template for our situation or to request the waiver of fees. Accordingly the Officers have prepared this paper report and respectfully request the wavier of outstanding fees and that this campaign account be formally closed.
