SUBJECT: Waiver of late filing fees standards

Enclosed are the waiver requests, which were submitted by campaign committees that have been assessed late filing fees. The attached Waiver Request Information Page contains an overview of each committee as well as the Administrator's recommendation for Board approval on granting a waiver request.

In the past the Board has considered the following facts in determining whether just cause exists to grant a waiver.

- Administrative error of any kind on the part of the Division.
- ☐ The lateness is due to extenuating circumstances, i.e. physical illness or death in the family.
- ☐ The late report is the first late report and allows the committee to close, or contains minimal financial activity.
- □ The fee will cause undue financial hardship, if the liability of the fine is the personal responsibility of the officers.
- Computer problems occurred which made timely filing impossible. However, the filer still must have demonstrated a good faith effort to timely file.

Prior to the meeting please review each waiver request. Note the recommendations that you may disagree with or have questions on that you would like to discuss.

Pursuant to Election Law Article §13-337 (b) (3), the State Administrator has denied nine waiver request. No Board action is required on the denials. Late fees collected year to date for Late Fee Waivers are \$7,633.82.

I'm writing regarding the missed 11/22 Filing for my campaign Committee Friends of William Roberts. I'm requesting a fee waiver or reduction of the currently pending \$1,000 fine. My treasurer and I missed this filing completely in error -in early November she went on CRIS to complete an amendment for the 8/10 report and to address a missed filing for the 10/28 report on 11/10. She also attempted to file the affidavit for the 11/22 report.

We had no contributions/expenditures to report as we lost our primary, so she attempted to file an affidavit of limited contributions. It seems that perhaps the report didn't process and send as it should have when she took care of the others - as has happened to me in the past - but we attempted to file for sure.

We'd both subsequently been in and out of town during this time and again we weren't closely monitoring for anything from SBE because we were under the impression that we were current. I saw an email in my spam alerting me to the fee running notice and called the SBE check out the affidavit filing but I was told it wasn't showing as filed and my campaign committee was subject to a max fine which I should request a waiver for under the circumstances I explained.

My campaign has a total of 2500 in our account to close out debts - I'm also a Montgomery County public financing candidate and Mr. DeMarinis and I had been communicating before the holiday about settling a 1,200 overpayment through the public financing system that he's showing on his end. I understand that fines exist for a reason, but I hope that the SBE would take the circumstances into account that 1) we attempted to file the affidavit and believing we had filed it - we have not been on the lookout for notices while on travel and 2) absorbing such a fine would leave us potentially unable to pay some campaign debt.

I'm aware that we also have a \$350 fine for a late filing of the 10/28 report - that mistake is completely on us and we intend to pay that \$350 fine.

Please note: As of this writing, I've tried to go on to CRIS to file the affidavit for the 11/22 report and the upcoming 11/18 annual and the system is not allowing me to do so for either - so I'm not sure how to process it currently and I'll call the SBE at OOB on the first working day after the holiday to try to sort it out.

So I'm hoping that you'll give this request consideration and allow this max fee to be waived given the circumstances. Thank you and I look forward to hearing back.

This memorandum serves as a request from the Carroll County Republican Central Committee
To waive the \$20 fine associated with the submission of the committee's 2022 Gubernatorial PostGeneral report which had a deadline of 11/22/2022.

Background:

Richard Norman, the previous treasurer of the CCRCC resigned his position on 10/28/2022. No treasurer was named to replace Norman in the MD CRIS.

New CCRCC committee members elected officers, (except for Treasurer) on 11/14/2022.

On or about 11/15/2022, the committee's previous chairman, Jason Sidock assured new chairman Joe Leeman that he would access the MD CRIS to install Joe Leeman as chairman. Mr. Sidock acknowledged that there was a sense of urgency since the deadline of 11/22/2022 was fast approaching.

Jason Sidock did not follow through on his word that he would access the MD CRIS to implement the changes.

On 11/21/2022 in a special meeting, Richard Collins was elected as Treasurer.

On 11/21/2022 Jason Sidock said he would access the MD CRIS on 11/22/2022 to install Richard Collins as treasurer and remove himself as chairman. Jason Sidock did not follow through on his word to install Collins as treasurer.

On the morning of 11/22/2022, Richard Collins called and spoke with Devki Dave of the Candidacy and Campaign Finance Division. During the conversation, Collins expressed the sense of urgency in having his name entered as CCRCC treasurer in the MD CRIS. Devki Dave said there was nothing that could be done until Jason Sidock accessed the system and entered Collins name as treasurer.

Collins called Devki Dave again in mid-afternoon. She said she tried to call Jason Sidock twice on 11/22/2022, (she left voice messages both times). Sidock never returned her calls. She told Collins that if the committee was unable to get Sidock to implement the changes, it could submit a request to waive the fines.

On 11/22/2022 at 11:31 pm, Richard Collins sent by email, an attached PDF of the Appointment – Treasurer form which appointed Richard Collins as treasurer of CCRCC. The form was signed by Joe

Leeman, Duly Elected Chairman of CCRCC and Richard Collins as new treasurer. The signed form was scanned to PDF and attached to the email which was sent to ccf.sbe@maryland.gov.

At 11:33 pm, Richard Collins sent a signed Affidavit of Limited Contributions and Expenditures form attached as a PDF to an email which was sent to ccf.sbe@maryland.gov.

On the morning of 11/23/2022, Richard Collins called and spoke to Jessica Perkins of the Candidacy and Campaign Finance Division. Ms. Perkins informed Collins that Jason Sidock had accessed the MD CRIS earlier that morning and resigned as chair. Sidock did not appoint Collins as treasurer within MD CRIS. Sidock did not reach out to Collins that morning to ascertain required information.

Note: On 11/17/2022 at 10:37 am Richard Collins sent an email to Jason Sidock with an attachment that included the completed Appointment of New Treasurer form. Collins' information was entered within that form including his date of birth, home address, phone # and email address.

Please accept this email as a request to waive the late fees for Contribution Disclosures reported to you for November 1, 2021 to April 30, 2022 on November 30, 2022. We had a Lobbyist for quite a few years. During that time I was the person who entered the information into the Contribution Disclosure System. However, in late 2019 we no longer used a Lobbyist. My contact there was Victoria Molina and she was most helpful to me if I had any questions or problems pertaining to the contribution disclosures and/or the system. I spoke to Victoria Molina during that time in 2019 and she told me she was going to DE-ACTIVE my username and password as we would not longer need to report the contribution disclosures if we did not have a Lobbyist. She instructed me to contact her if we ever used a Lobbyist again and she would reactivate my user name and password.

We no longer received emails reminding us to send the reports. In January 2022 we hired another Lobbyist, Evans & Associates. Honestly, I did not think about the disclosure reports at all nor did I receive emails prompting me to send the reports. In early November 2022 our General Manager (and co-owner), Randy Clemens received an email regarding the Contribution Disclosure Report for the Fall of 2022 due on November 30. Randy emailed that to me. At that point I went into the disclosure system and found I could not sign in using my user name or password. I called immediately to help me get this reinstated as we were using a Lobbyist again. I

spoke to Devki Daveon 11/16/2022.

Devki was trying to help me but realized there were two Arundel Amusements in her system . There was one as Arundel Amusements Inc. dba Bingo World. And the other was just Arundel Amusements. They both had Randy Clemens name on them but not mine. Devki told me she needed to look into this to see how she could fix it. Devki asked me to go in and re-register the information. I did this but I still could not sign in. Once this was finally resolved I went onto the system on November 28 to

begin entering the Contributions.

While doing this I noticed I had to compete the contribution disclosure report for Spring AND Fall. I called Devki and she asked that I send her an email to back date the system so I can also submit the Spring contributions. Remember, I had not received anything from them until the Fall. I went ahead and entered all information I had so as not to get penalized. At this point I had entered contributions for Spring, 11/1/2021 to 4/30/2022 and Fall, 5/1/2022 to 10/31/2022. I also received a confirmation for both were received from the MD State Board of Elections. I was so relieved this was done, we were up to date, and my password was updated, and I was prepared to report future contributions.

My boss, Randy Clemens received an email from the State Board of Elections indicating they had not received the Contribution Disclosure Reports. I immediately called them and spoke to Ebony. She explained to me they received our disclosure reports but the one for Spring was supposed to be completed and sent by 5/1/2022. But it was not received by the deadline date of 5/1/2022. They did not receive it until 11/29/2022. She also indicated I would have to pay the \$1,000 penalty for being late.

I am requesting to waive the penalty fee. I have always submitted my reports in a timely fashion in the past years. I had been away from it and I honestly forgot about it. That is until Randy Clemens received the email with the deadline date of 11/20/2022 for the Fall disclosure report. In all honesty I also ensured ALL contribution

disclosures were reported at the time we were notified to submit by 11/20/2022. I am asking forgiveness and to waive the penalty this time.
