**SUBJECT:** Waiver of late filing fees standards

Enclosed are the waiver requests, which were submitted by campaign committees that have been assessed late filing fees. The attached Waiver Request Information Page contains an overview of each committee as well as the Administrator's recommendation for Board approval on granting a waiver request.

In the past the Board has considered the following facts in determining whether just cause exists to grant a waiver.

- □ Administrative error of any kind on the part of the Division.
- ☐ The lateness is due to extenuating circumstances, i.e. physical illness or death in the family.
- ☐ The late report is the first late report and allows the committee to close, or contains minimal financial activity.
- □ The fee will cause undue financial hardship, if the liability of the fine is the personal responsibility of the officers.
- Computer problems occurred which made timely filing impossible. However, the filer still must have demonstrated a good faith effort to timely file.

Prior to the meeting please review each waiver request. Note the recommendations that you may disagree with or have questions on that you would like to discuss.

Pursuant to Election Law Article §13-337 (b) (3), the State Administrator has denied eight waiver request. No Board action is required on the denials. Late fees collected year to date for the month of June are \$25,541.00

Initially, you denied my waiver request however, new information is being furnished that had an adverse effect on filing my campaign report on time. My nephew who I raised, sheltered and cared for since birth was shot in Baltimore city (I have documentation). After released from the hospital I was his sole caregiver as he couldn't do anything for himself. Thereafter, I was diagnosed with severe anxiety and depression and placed on sleep and psychiatric medications (I have documentation) during the time my report was due. Most things was oblivious to me. I was not in a good frame of mind. As the candidate, I was never charged with filing the report. Due to medical issues of her own my initial treasurer uprurblty resigned and relinquished all responsibilities which left me scrambling for someone to replace her. I found my current treasurer who is not trained in accounting, finances, and has never filed a campaign finance report. However, he was willing to help me as best he could. Mr. Bratcher spoke with several of the staff within the candidates campaign finance department who tried to help him navigate and understand the campaign finance reporting system to no avail. Mrs. Diane Zagorski was vey helpful in her attempt to help Mr. Bratcher file the report whom he was in constant contact with to get the report filed in a timer manner. I spoke to Victoria Smith as well regarding the report that I thought was filed. Mr. Bratcher told me the report was filed and the staff within the campaign finance department helped him complete and file the report. Contrarily, Mr. Bratcher obliviously did not complete the last step to complete the filing process. There was a button at the end that he never hit to submit the report as he was unaware that the report was not filed. He thought that when the Mrs. Zagorski guided him to complete the report that it was complete. Mr. Bratcher himself was going through medical issues with his 8 year old daughter as she was hospitalized during this time for approx. four (4) months. Initially, I was not made aware of all Mr. Bratchers issues with his daughter. He has full custody of his daughter and as the sole parent it was hard for Mr. Bratcher to focus on my campaign report and did not realize it wasn't filed initially. During this same timeframe Mr. Bratcher was facing an eviction (which I have documentation). All the months that the report was not filed we did not know it was not filed. This entire process was new to us both and we were both ignorant to this process and going through life altering issues. We did not just deliberately, intentionally, willingly or knowingly neglect to file the report. We believe that we are able to demonstrate having put forth a good faith effort to cooperate with the state and county finance departments throughout the process of submitting our last finance reports and closing out our campaign account. When we did receive notifications that indicated something may have been incorrect or lacking in our filings, we began making an effort to communicate with interested parties to determine next steps toward resolution. We did not want to proceed from that point without guidance from the state finance department, as we believed that was the most viable path with regards to circumnavigating potential for additional mistakes.

In the months since November 2022, we have several documented interactions with David Crow with the Montgomery County finance department who was not able to identify the issues with our reports, and informed us that we had to communicate with the State. We attempted to contact key individuals at the state level on multiple occasions via phone and email, but unfortunately, we rarely received a response. On the one occasion we did receive a response to our initial attempts, our request to schedule a follow up conversation went unanswered. When we received a letter via email and USPS that said we had a late notice for not filing a campaign finance report, we did not know how to proceed, since we had previously contacted the state multiple times and did not receive any responses. We had been in contact with Jared Demarinis many times prior to the general election, as he was our primary contact within the state finance department. Despite our best efforts, we were unable to determine, based on our knowledge of available resources (Jared (State) and David (County)), what we were doing wrong with this report. We were finally able to address these issues in March of 2023. David Crow and the Montgomery County finance department reached out to the state on our behalf, and we were then able to set up a video conference with the state to better understand what was required in order to resolve the issue.

We believe that our demonstration of good faith effort to comply over a period of several months is justification for the late fee waiver request. We have appended to this document proof of email interactions that detail the lack of response from the state. These interactions confirm our ongoing confusion with the process of closing out our campaign account. Earlier reciprocation of our communication efforts, we believe, would've results in a much faster resolution and an avoidance of an of the fines that have been charged.

We are happy to engage in further communication to review the email documentation and phone interactions upon request.

- 2. The lateness is due to extenuating circumstances, i.e. physical illness or death in the family; or
- 3. Computer problems occurred which made timely filing impossible. However, the filer still must have demonstrated a good faith effort to timely file.

Prior to the meeting please review each waiver request. Note the recommendations that you may disagree with or have questions on that you would like to discuss.

#### § 14-107(c) Late Filing Fees

- (1) As provided in this subsection, the State Board may impose fees for late filing of:
  - (i) a statement required under § 14–104 of this title; or
  - (ii) an amended statement required under subsection (b) of this section.
- (2) The State Board may impose late filing fees in the same amounts and in the same manner as provided under § 13–331(a) and (b) of this article for late filing of campaign finance reports.
- (3) Late filing fees imposed under this subsection shall be distributed to the Fair Campaign Financing Fund.

Pursuant to COMAR 33.20.07.01C, the State Administrator has denied five late fee waiver request. No Board action is required on the denials.
