**SUBJECT:** Waiver of late filing fees standards

Enclosed are the waiver requests, which were submitted by campaign committees that have been assessed late filing fees. The attached Waiver Request Information Page contains an overview of each committee as well as the Administrator's recommendation for Board approval on granting a waiver request.

In the past the Board has considered the following facts in determining whether just cause exists to grant a waiver.

- □ Administrative error of any kind on the part of the Division.
- ☐ The lateness is due to extenuating circumstances, i.e. physical illness or death in the family.
- ☐ The late report is the first late report and allows the committee to close, or contains minimal financial activity.
- □ The fee will cause undue financial hardship, if the liability of the fine is the personal responsibility of the officers.
- Computer problems occurred which made timely filing impossible. However, the filer still must have demonstrated a good faith effort to timely file.

Prior to the meeting please review each waiver request. Note the recommendations that you may disagree with or have questions on that you would like to discuss.

Pursuant to Election Law Article §13-337 (b) (3), the State Administrator has denied nine waiver request. No Board action is required on the denials. Late fees collected year to date for Late Fee Waivers are \$7,633.82.

I was advised in speaking with "Jessica" at The Maryland State Board of Elections TODAY: 2/1/23 to petition The Board for a waiver of all fees relating to inadvertantly not filing a Campaign Finance Report (CFR) for the last (2) timeframes, I believe.

Mr. Blanton-- a first time candidate--and I--a first time treasurer--filed all prior CFRs as directed without incident. Mr. Blanton did not win his election. He decided to no longer keep an open account and we filed what we believed to be the last report we were required to submit the next quarter after the election. I sumitted that report and we noted that we had also closed out the campaign's bank account-- with Shore United Bank--on 11/21/22 with a "0" balance. The account tracked all deposits and expenditures and mirrored every CFR filing.

I did not know--though ignorance is no excuse--that we should also have filed a 'Close Out Report" to alert your agency that this account would no longer be "open" and utilized.

I filed this report TODAY--within hours of speaking with "Jessica". I am now emailing The Board in the hope that once I realized our error and in good faith attempted to reconcile all CFR's by filing The Close Out Report as instructed with your agency with the utmost alacrity, The Board might forgive the subsequent fees we inadvertently were amassing.

At this juncture, we are awaiting both confirmation that we have finally successfully closed out Mr. Blanton's account and that the campaign will not be required to pay the fees engendered as a result of my inexperience.

After the exhaustion of campaign funds, the fee would be borne personally by the officers. The officers are unsophisticated first-time campaigners making a good faith effort to participate in our democracy. The chairman is presently a student and the \$1,000 fine would represent a significant burden. Imposing fees upon officers personally would have a depressing effect on future democratic participation.

The public was not deprived of any information regarding the activities of the campaign. After losing the primary, the campaign larged ceased activity, spending no money. The campaign finance report in question contains no actions. Under Maryland's "sore loser" laws, this was largely required. All campaign reports up to the primary were promptly and correctly filed. The only benefit of the reports to the public would be a confirmation that a completed campaign was inactive. The only remaining activity that the campaign seeks to perform is to close out.

Finally, there were some mitigating circumstances. The candidate/chairman's grandfather died in October and the candidate/chairman traveled out of state to attend the funeral. Letters to the treasurer in this time frame were incorrectly delivered to the candidate's mailbox by building staff and went unread for some time.

#### Dear Board Members:

New information that assures me that my inability to file reports efficiently was not due to user error, as I had presumed but rather system errors with MD CRIS that continue to persist.

Accordingly, I am updating my request for a waiver. Not being reimbursed the earlier paid \$350 fine would be an unjust ruling given the Maryland SBOE has now confirmed that there were system errors complicating my attempts to file the report timely.

It would additionally be an unjust ruling if the Board required that I pay a \$2000 fine for not filing reports that would have reflected zero expenditures and zero contributions for an election phase to which I had not advanced and in which I did not participate. No harm resulted from this good faith review and interpretation of the rule.

In my earlier submitted waiver request, dated December 30, 2022, I referenced that I was able finally able to file the report due on July 8, on July 21, with assistance from SBOE. The challenges I experienced when attempting to file the report on July 8 were due to persistent SBOE errors, as SBOE later informed me after I had submitted the waiver request dated December 30.

Please note that at all times, the SBOE staff have been first class. Each person with whom I have interacted has been incredibly gracious, kind, well-informed and quickly responsive to my requests for assistance. Without the staff, I would still be trying to figure out why each entry in MD CRIS was getting duplicated. Nor would I have been able to ultimately file the reports work around ongoing system errors.

# 1. MD CRIS system errors—not user error—were the primary cause of my delay in filing the July 8 report such that I filed it on July 21.

Throughout the 2022 summer of filing reports, I was not able to make MD CRIS tabulation exactly match the spreadsheet totals that I was uploading.

Initially, the errors were small. After triple checking my uploads and confirming the information was correct, the system would still present a slightly different number. Because the differences were relatively small, I continued to move forward. However, when I began preparing the reports in advance of the July 8 deadline, the system reported numbers significantly different from my uploads and internal records.

Because I was solo-parenting my five-year old at the time, with my husband and treasurer both traveling overseas, I delayed filing the report because I did not want to file information in advance of the Primary election that I knew to be wildly incorrect.

After the election, I received assistance from your office to file the report. I learned that the contributions were duplicating themselves after I submitted them to MD CRIS, but at the time SBOE staff did not know why. In July and in August of 2022, your office helped me systematically go back through each report to remove duplicate entries of contributions.

In January 2023, when the office returned my call to discuss how to make the numbers properly align in the closeout report, I learned that MD CRIS itself was duplicating entries due to a system error and that staff had to help ensure that there were not duplicate entries in the submissions of several candidates.

This meant that my ability to efficiently file the July 8 report was not a user error, as I had presumed. Instead, I was not able to overcome the system error. That same system error had affected my two previous reports, such that by the third report there was an uncomfortable distance between my internal records and what MD CRIS was tabulating.

At the time, I believed the fine to be only \$20 per week so I waited to file until I had the bandwidth to figure out the problem. I did correct the problem with help from your staff, but I still believed it to be user error on my end, which it was not. Had the system worked properly when I tried to file my report on July 8, I would have been able to file it timely.

I should not be fined for not being able to file a report efficiently due to system errors. If I had understood there were system errors at the time affecting multiple candidates, I would have requested permission to file paper reports, which I could have done timely.

- 3. Computer problems occurred which made timely filing impossible. However, the filer still must have demonstrated a good faith effort to timely file.

#### § 14-107(c) Late Filing Fees

- (1) As provided in this subsection, the State Board may impose fees for late filing of:
  - (i) a statement required under § 14–104 of this title; or

Dear Mr. DeMarinis,

Monumental Paving & Excavating, Inc. ("Monumental") recently received an aggregate \$10,500.00 violation fine related to a comprehensive disclosure of relevant, historical contributions that the company made this past Fall. The purpose of this letter is to provide further context to the disclosure with the hope that the Maryland State Board of Elections might consider a reduction in fines given Monumental's good-faith intent and the spirit of the campaign finance laws.

Monumental is a general contractor that has performed construction projects for private owners and various Maryland municipalities since its inception in 1984. As engaged citizens, officers of Monumental have also made contributions to different political campaigns throughout the years. All contributions have always been properly disclosed on candidate committee reports; there has <u>never</u> been any intent to conceal contributions, deceive reporting authorities, or otherwise not fully comply with all campaign finance laws.

However, this past Fall, Monumental became aware of the additional and separate disclosure requirement by business entities that do public business with Maryland municipalities. Upon learning of the requirement, Monumental immediately sought to disclose those same, historical individual contributions to comply with the state's Disclosure by Business Entities laws. As such, Monumental made a number of disclosures across a variety of historical periods at one time, which is the reason for the large fine balance of \$10,500.00.

Monumental is immensely regretful and apologetic of its oversight of the state's Campaign

Finance requirements for business entities, as its objective has <u>always</u> been full compliance with all

Maryland, federal, and local laws. Monumental is a firm of high integrity that takes immense pride in its
reputation and does not wish for any appearance of impropriety. As such, upon learning of its misstep,

Monumental promptly and comprehensively self-reported. Monumental has also taken steps to implement internal controls such that it is always compliant and timely with its future disclosures.

Monumental understood that it might incur some penalty, but the totality of the fines felt excessively punitive on a small, local business that is trying to act in good faith with the spirit of the law. Monumental sincerely hopes that some leniency can be shown, and would be deeply appreciative of any waiver or similar relief that the Board might consider, given the context around its disclosure.

Ladies and Gentleman of the Board:

On behalf of Odyssey Investment Partners Fund IV, LP ("OIP IV") and Odyssey Investment Partners Fund V, LP ("OIP V" and together with OIP IV, the "Funds"), Odyssey Capital Partners IV, LLC and Odyssey Capital Partners V, LLC (together, the "General Partners" or "we"), acting as the general partners of OIP IV and OIP V respectively, would like to formally request a fee reduction for failure to comply with the 2017 Maryland Code on Election Law (the "Code"), Title 14, Section 14-104.

OIP IV initially entered into an investment contract with the Montgomery County Employees' Retirement System ("MCERS") on February 4, 2009, in excess of \$200,000. On December 20, 2013, OIP V entered into an investment contract with MCERS in excess of \$200,000.

At the time the contracts were entered into by the Funds, MCERS notified the Funds that they were exempt from making any filings pursuant to the Code. At no time from the initial contract until the date hereof did the Funds or any affiliate make political contributions in the State of Maryland to any state officeholder covered by Title 14 of the Code.

MCERS recently notified the Funds that, due to a change in the law, the Funds were now subject to regular reporting obligations under the Code. As soon as MCERS provided the notice, we initiated an inquiry to confirm whether the Funds have any reporting obligations. After discussions with a representative from the Maryland State Board of Elections, it came to our attention that a 2016 update to the Code caused the contracts with MCERS alone, and without being coupled with political contributions by the General Partners or their affiliates, to give rise to filing requirements with the State of Maryland. Accordingly, the Funds will initiate the process of completing the requisite filings.

Given that the Funds have not been in compliance with the mandated reporting requirements since the 2016 Code revisions, and failure to submit the semi-annual filings gives rise to a monetary penalty, we would like to submit a request to have the fee burden owed by the Funds reduced. We understand the State of Maryland's interest in having transparency regarding private entities entering in contracts with public officials. The Funds intend to submit all

necessary filings moving forward. Additionally, we would like to note that we have been proactive in rectifying any past failures of the Funds to meet their reporting requirements and ascertaining the Funds' future obligations to the State of Maryland. Accordingly, we would ask that the Maryland State Board of Elections consider reducing the fees owed by the Funds as a result of any previous non-compliance.
