SUBJECT: Waiver of late filing fees standards

Enclosed are the waiver requests, which were submitted by campaign committees that have been assessed late filing fees. The attached Waiver Request Information Page contains an overview of each committee as well as the Administrator's recommendation for Board approval on granting a waiver request.

In the past the Board has considered the following facts in determining whether just cause exists to grant a waiver.

- □ Administrative error of any kind on the part of the Division.
- ☐ The lateness is due to extenuating circumstances, i.e. physical illness or death in the family.
- ☐ The late report is the first late report and allows the committee to close, or contains minimal financial activity.
- □ The fee will cause undue financial hardship, if the liability of the fine is the personal responsibility of the officers.
- □ Computer problems occurred which made timely filing impossible. However, the filer still must have demonstrated a good faith effort to timely file.

Prior to the meeting please review each waiver request. Note the recommendations that you may disagree with or have questions on that you would like to discuss.

Pursuant to Election Law Article §13-337 (b) (3), the State Administrator has denied three waiver request. No Board action is required on the denials. Late fees collected year to date for the month of September are \$103,592.00

Dear Ms. Hanzook,

I am writing to you as Treasurer of Maryland Architects PAC. I am following up on the results of our internal audit, our amended reports, and the resultant late reporting fees.

Upon receiving multiple fee notices in May, 2023, from the State Board of Elections, the PAC retained an accountant to perform a comprehensive review of our filings. Based on our discoveries, the accountant's review expanded to several years beyond the reports requested by the State Board of Elections.

We have submitted amended reports and; as of September 5, 2023, you have accepted all of the amended filings. While there were clearly errors in the reports, they were clerical errors and none of them were purposefully intended to provide false information or to otherwise benefit the PAC. Instead, they were the result of volunteers who were inexperienced with the reporting procedures. The PAC treasurers were and are architects and not accountants.

Because the clerical errors had taken place over such a long period of time, the accountant had to reconstruct 10 years of financial information to assure that the revisions were completely accurate. Once discovered, we made every effort to correct the issues as expeditiously as possible. Unfortunately, the process took time and fees have accrued. At this point the fees exceed the financial resources of the PAC.

We are hoping that your office will acknowledge our additional efforts in going beyond the scope requested to ensure accurate reporting and waive a good portion of these fees. Please advise us of any formal process to request relief of these fees, and whether or not this should be addressed to you or to another office within the State Board of Elections.

The basis for the request

The request must provide just cause for the waiver of the late fee(s).

Our appeal concerns both the most recent (January 2023) periodic report as well as our responses to more than a half-dozen audit reports. Slow to answer the Board's requests, this committee was eventually levied heavy fines. We are appealing the fees related to the period during which we were unable to upload data into CRIS.

Finally we are appealing the fees subsequently levied against the Baltimore City Republican Central Committee for not paying the original fees (as mentioned in correspondence to us on 21 August), as such fees should not be imposed when the underlying fee has been unjustly levied or improperly calculated.

First, let me state that as Chairman of the Baltimore City Republican Central Committee, I take full responsibility for the administrative nightmare that has befallen the city GOP and the good people who comprise its central committee.

I will gladly resign the chairmanship of this committee if doing so alleviates the committee of the substantial fines now levied against it.

I assure you that our lateness has not been the result of indifference, malfeasance, or bad faith on anyone's part. After many weeks of exhaustive review conducted by our new Treasurer, Sheikh Selim, and I, we recently submitted amendments to every report since 2020, and have now almost entirely balanced our books. I am hiring an accountant to help us address the remaining discrepancy, which is less than one hundred dollars.

While there are numerous reasons for our inexcusably late responses to your request for reports, I do not contest the general findings of the Maryland State Board of Elections. The Baltimore City Republican Central Committee was delinquent in furnishing numerous current and past reports. True, we are contesting the amount of the fees, as we believe we responsibly attempted to furnish reports far earlier than has been alleged (a fact we shared by phone and through numerous emails with Ms. Diane Zagorski, a member of your administrative staff). We hope that our unsuccessful attempt to report promptly will be taken under consideration and that it may alleviate us in some measure from the crippling fines that have been assessed. Finally, we fully understand our obligation to provide the Board periodically with timely and accurate CRIS reports and to upload specific data related to contributions and expenditures. In this, we failed. More specifically, I failed.

Until this episode, I regarded myself as a competent administrator. But I see now that in my desire to focus on long-term goals and the big picture, I failed to attend to the immediate details that must be addressed if an organization is to be successful.

Please do not think we have been idle or indifferent to the committee's obligations to administer its books. If anything, we were hobbled by bad luck. Since our committee elected officers less than a year ago (November 2022), three individuals have served either formally or informally as Treasurer: Michael Nolet, Nicholas Wentworth, and Sheikh Selim. Dr. Nolet had been reelected to the central committee during the July 2022 primary. At our quadrennial first meeting last November, the committee elected him Treasurer.

However, his participation was limited from the start. A psychologist by profession, he quickly realized that accounting was neither a skillset nor of particular interest to him. He did not register in CRIS. His last committee meeting was in January. By February 16th, Dr. Nolet indicated an intent to leave the committee. On March 30th, Mike Nolet suffered a mild stroke and resigned his membership effective June 14. As Dr. Nolet's lack of involvement was becoming evident, I turned to the only other member with experience in this area: Nolet's predecessor, Nicholas Wentworth. Nicholas had been elected Treasurer four years earlier. From 2019 to 2022, his involvement amounted to little more than drafting checks and maintaining our bank and CRIS accounts. For the current election cycle, at my urging, the committee elected him as our Deputy Treasurer. While I had no reason to doubt Mike, I didn't want to lose Nicholas's skillsets or institutional knowledge, despite his own limited ability to serve in the role. Nicholas's day job (which required frequent overtime) and family commitments (married with a new child) had always constrained his involvement. So, as Mike was fading, Nicholas graciously stepped in, but his involvement involved only basic treasurer functions. It should be said of Nicholas that he almost always entered contributions and expenditures accurately into CRIS. In our recent review of the CRIS reports, Sheikh Selim and I noted that his accounting errors were limited to several high-value fundraising checks for which duplicative entries were made and for failing to note the per-check fees assessed by Nationbuilder (Democracy Engine), which over the course of two large fundraisers had created an aggregate (but heretofore unreported) expenditure of over \$1,000. As mentioned above, these errors have been corrected and the books brought almost into full balance.

Importantly, Nicholas also noted that still listed in CRIS as the committee chairman was the name of my predecessor, Shannon Wright, a critical element that would explain in part why the committee was late in responding to the audits.

In May, Nicholas asked to be relieved of his volunteer duties, and at our June meeting the committee elected Mr. Sheikh Selim, a young man whose energy and commitment were instrumental in helping me to unravel the inconsistencies which the auditors found in more than a half-dozen reports.

This is the environment in which we operated over the past year. We tried in good faith to ensure our committee had a Treasurer who would faithfully execute his responsibilities. But when it rains, it pours. Had the Deficiency notices been mailed in May to me and to Nicholas, most of the issues we now face might have been painlessly resolved. However, at that time, Shannon Wright was still listed in CRIS as chairman. I do not know if Shannon was receiving email or mailed audit notices from CRIS, but she never informed me nor did she pass them to anyone on the committee before submitting her resignation in April this year. Also posted in CRIS at that time was the name and address of Nicholas Wentworth, but Nicholas had moved to another residence the previous year and, given his change in address, may not have received the mailed deficiency notices. I suspect he ignored any emails received from the Board of Elections, because he no longer had time to assist us and honestly believed he had already taken sufficient steps to help install his successor.

It was only in June when both Sheikh (6/20/23) and I (6/16/23) were registered in CRIS. Until then, neither of us were aware of the delinquent January 2023 report or the many audit deficiencies. I do not offer this as an excuse, because the simple fact is that I should have been listed in CRIS, and this singular failure is the proximate cause of the difficulties we now face. I can offer no good reason why I was not. In attending to the general management of the committee, I believed I was acting responsibly by addressing the succession of Treasurers, requesting monthly summaries of funds expended and received (which I reported in our meeting agendas), and encouraging new fundraising activities. I didn't see the ticking time bomb under my nose.

At this point in the narrative, it is appropriate to discuss in some detail the efforts Mr. Selim made to

respond to the audit deficiencies once he assumed office.

The audit deficiency notices were first transmitted via CRIS to the Central Committee chairmen and treasurers on May 17. Responses were due no later than June 21st.

A day earlier, on June 20, Sheikh and I received electronic notice of our CRIS registrations. The notice did not inform us of the audit reporting deadline then only a day away. I am not challenging the contents of this letter, but simply explaining that the letter did not prompt us to action. It would be several days before Sheikh or I reviewed the CRIS website and learned the full gravity of the delinquent reports.

On June 28, Sheikh attempted to address the 2022 Annual, 2022 Preprimary 1, 2022 Preprimary 2, 2022 PreGeneral 2, 2022 PreGeneral 1, 2022 PostGeneral, and 2021 Annual reports. At first, Sheikh believed CRIS accepted the modifications he had entered. However, he soon realized that his requested changes had not gone through.

On June 29, Mr. Selim sent an email to the SBE, Subject: Request to Cease Charging Late Fees for Baltimore City Republican Central Committee. It read as follows:

Dear Maryland State Board of Elections,

I am writing to bring to your attention some significant issues we have encountered with the Maryland Campaign Reporting Information System (MDCRIS) and to request that the Baltimore City Republican Central Committee be exempted from any further late fees until these issues are resolved.

I believe it is important to address these concerns promptly to ensure fairness and accuracy in the reporting process.

Firstly, we have observed that MDCRIS did not display the upcoming filing dates for the Audit report on its reminders page. This omission created confusion and hindered our ability to meet the required deadlines. We kindly request that future reminders include all necessary filing dates to avoid any potential oversights.

Furthermore, we were only notified about late amendments a week after they had already begun to be filed. This delay in communication severely impacted our ability to comply with the necessary reporting requirements. It is crucial for us to receive timely notifications about any amendments or updates to ensure accurate and up-to-date finance campaign reporting.

Additionally, we encountered a significant malfunction within the MDCRIS system. Not only did the system incorrectly indicate that the Treasurer's password was incorrect when attempting to sign off the Amended Campaign Finance Report, but it also altered the amendments altogether and removed essential 2021 annual information from the system. Moreover, it inexplicably modified the "New Ending Cash Balance on Hand" figures to almost double the original amounts. These technical issues have severely compromised the integrity of our financial reporting, and we urge you to investigate and rectify them immediately.

Moreover, we have experienced great difficulty in reaching the MDCRIS support team. Despite multiple attempts to contact them via the provided support number, our calls have gone unanswered, and we have been redirected by automated voice prompts. This lack of accessible support has further hindered our efforts to address and resolve the aforementioned issues. We kindly request that appropriate measures be taken to ensure prompt and responsive customer support for MDCRIS users.

Considering the severity of these system failures and the resulting disruptions to our reporting process, I kindly request that the Maryland State Board of Elections refrain from charging any further late fees to the Baltimore City Republican Central Committee. It is evident that the current MDCRIS system is not functioning adequately, and it would be unfair to penalize us for delays and inaccuracies caused by these technical difficulties.

Alternatively, I propose that any late fees be suspended until a few days after the upcoming long weekend. This additional time would allow us to assemble a team of individuals who can thoroughly assess and address the issues arising from the malfunctioning system. By extending this grace period, we can work towards resolving the problems effectively and ensure the accurate and timely reporting of campaign finances.

I sincerely appreciate your attention to this matter and kindly request that you treat it with the urgency it deserves. I believe that by addressing these issues promptly, we can uphold the integrity of the reporting process and maintain fairness among all political committees in Baltimore City. Thank you for your understanding and cooperation.

On Friday, June 30th, the SBE responded with two emails, the first at 9:27 am...

At 9:59 am, Ms. Zagorski provided a second response:

Mr. Sheikh,

Thank you for your feedback. I will share with the appropriate parties and with our software vendor.

We are unable to prevent further accrual of late fees. The committee can stop late fees from accruing by filing an amendment to address bank balances or other errors. Although not all items will be addressed, this could be a great starting point for subsequent amendments.

The committee can request a waiver from the Board for their review.

On July 5th, with our issues still unsolved, Mr. Selim again wrote to the SBE reiterating our concern and requesting assistance:

Dear Maryland State Board of Elections,

I am writing to address a critical matter concerning the recent filing of amendments using the MDCRIS system. I have encountered significant issues during the filing process, resulting in the loss of our 2021 records and incorrect bank balance calculations. I kindly request your immediate attention to rectify these problems and restore our entered data.

To provide clarity on the issues encountered, I have attached "before" and "after" documents, illustrating the discrepancies in the information displayed for the amendments. Initially, when attempting to file the amendments, the system consistently requested another officer's signature. However, upon obtaining the signature, the system erroneously deemed the password provided as incorrect, despite our careful verification of its accuracy.

Furthermore, despite the system's notification indicating that the amendment did not go through, it inexplicably deleted our 2021 filings and associated records. This unexpected deletion has caused significant inconvenience, as it is now impossible for us to access crucial information. Therefore, I urgently implore you to take immediate action to restore our 2021 records in their entirety.

As the newly appointed treasurer, I find myself in a challenging situation due to the lack of comprehensive data. I possess only a limited amount of information from the bank, which restricts my ability to accurately record transactions made during the affected period. Consequently, it is of utmost importance that the MDCRIS system promptly returns our entered data, enabling us to proceed with any necessary amendments accurately.

In light of the circumstances outlined above, I kindly request the following actions be taken:

Restoration of 2021 Records: Please prioritize the restoration of our 2021 filings and associated records, ensuring that all data is reinstated accurately and completely within the MDCRIS system.

Resolution of System Issues: Please thoroughly investigate the technical issues encountered during the filing process, specifically the system's refusal to accept the amendments initially and the subsequent deletion of our 2021 data. It is imperative that these issues are addressed promptly and remedied to prevent further complications.

I trust in the expertise and professionalism of the Maryland State Board of Elections to handle this matter expediently and efficiently. Given the time-sensitive nature of this request, I kindly urge you to provide a prompt response and keep us informed of the progress made in resolving these critical issues.

Thank you for your attention to this matter. I look forward to your prompt response and a swift resolution to the problems encountered.

On July 6, Ms. Zagorski responded as follows:
Thank you for this information. I have notified our software vendor and marked the ticket as critical.
Later that afternoon, at 3:53 pm on July 6, Ms. Zagorski provided the following information:
I was informed by our software vendor that the issue has been resolved.
On July 10, Mr. Selim amended and filed all reports.
On August 7, at 3:54 pm, following a telephone conversation with Mr. Selim and myself, Ms. Zagorski sent

the following:

As follow up to our conversation, I opened the support ticket #4675426417 to inquire as to why the amendment for the 2021 Annual filed on 6/28/2023 did not update the subsequent reports. As a result, the system is not recognizing the subsequent reports as being amended until 7/10/2023. I do not have an ETA on when our vendor will have more information on this issue.

END OF EMAIL COMMUNICATIONS

Fees were being levied against the Baltimore City Central Committee during this period (6/28 thru 7/10), even though we had attempted to comply with CRIS requirements and respond promptly to the report deadlines as early as June 28th. Indeed, per Ms. Zagorki's emails, the software vendor acknowledged the technical issues confronting us and reported to her that those issues were resolved on July 6th. Four calendar days later, Sheikh entered all required data.

For the reasons stated above, I respectfully request a reasonable mitigation of the original late filing fees and dismissal of the subsequent "failure to pay" fees.

Dating back at least six decades the Baltimore City Republicans have been in the political wilderness, unsuccessful at filling even a single city council or general assembly seat. Recently, however, they have enjoyed a few rare "wins." After a decade of inactivity, they've held several successful fundraisers, which in turn helped them field a number of fine candidates in the general election. I deeply regret that my failures

as chairman now jeopardize the committee's ability to build on the committee's hard work over the past several years. They deserve better. The shortcomings of the committee over these past few months, including its failure to respond promptly to your reasonable filing requests, are entirely my own. For my inattention to the administrative details which comprise my office, I offer my resignation. While it is not necessarily yours to accept in any official capacity, I offer it nonetheless in the hope that, by this gesture, you will give due consideration to my earlier efforts to install a competent, full-time Treasurer, as well as our numerous unsuccessful attempts, shortly after Sheikh and I registered in CRIS, to file timely responses to your audit requests. I will gladly relinquish this position if by doing so the Board will mitigate the onerous fines which, if imposed, will effectively undo the only true progress our committee members have made in the past ten years. The committee itself is blameless; its members are industrious and well-intentioned, and in a just and objective adjudication they would not bear the consequences brought about by the shortcomings of their committee chairman. I therefore request that you remediate the assessed fines and, by doing so, enable the BCRCC to continue to perform its functions.

We have a recently newly appointed campaign treasurer, Leslie Hansley. She has worked very hard to complete an accurate audit of our campaign finances dating back to the 2014 Primary Election and 2018 Primary Election. She was the treasurer for the 2022 Primary Election.

With her efforts, we have completed a thorough review of all of the campaign reports and bank statements for the 2014 and 2018 and 20122 Primary Elections.

Her work was made more difficult, due to the fact that our campaign treasurer for the 2014 Primary campaign, William Earley, had passed away. We previously requested and received a late fee waiver from the Board after notifying you that he was ill and had died.

For the 2018 Primary campaign, Jeffrey L. Jackson was our campaign treasurer. He resigned prior to the 2022 Primary campaign. Mr. Jackson was very, very thorough in his supervision of the committee's campaign finances, and he was very diligent in providing accurate reports to the online system. What we discovered during our complete review, dating back to Spring 2014, is that, notwithstanding that he had uploaded information from his spreadsheets to the CRIS, expenditures were reported, but contributions were not. Nonetheless, he received several confirmations from CRIS that the information was properly uploaded, when in fact, fifty nine (59) contributions were not uploaded to the system. Ms. Hansley discovered that issue and we diligently searched for and found the contributor records, and we uploaded them manually to CRIS, for a complete record.

As previously communicated to SBE, our former campaign chairman, Ms. Charlotte Coffield is in memory care in Silver Spring and has been unable to perform her verification responsibilities as chair for several years.

With three campaign treasurers since 2014, and the problems we discovered with the 2018 contributions, the SBE-requested audit took longer than expected.

The audit has been completed and we believe that we are in full compliance with SBE requirements for reporting.

It is for the above reasons, we request a waiver of the late fee of \$480 dollars from the State Board of Elections.

I mistakenly received \$6,250 from a single individual during the 2019-22 cycle and this was reported to me during your audit. I contacted my donor (Ballard Jamieson) and explained the situation and he requested that I refund him \$250, and his wife (Diana Jamieson) would make a donation of the same amount. These transactions were accomplished in the first week of August. We then had difficulty following the instructions on how to record these transactions in compliance with the Deficiency Report Notice. The Deficiency Report Notice directed us to file an amended report - which presumably would have been the 1/19/2022 Annual. However, there was no option to amend that report available on line. We could not amend the actual transaction because the corrective actions took place in 2023, not when the prior donations were received. We tried to enter a "Return Contribution" using the left side menu; however, the webpage did not allow us to select a "Filing Period" and we could not complete that submission. We found that the only way that we could file the information - which was consistent with the instruction on the Deficiency Report (not the notice) - was to enter a "New Return Contribution" from the blue buttons on the bottom of the website, while completing a new filing. We successfully did this as part of the 1/17/2024 Annual Report (the only report option available), including both the new donation and the return donation. This was filed on 8/6/2023, before the deadline noted in the Deficiency Report. We thought we were done. Then on 8/11/2023, we received notice that you had not received our amended campaign finance report and that we were being fined. On 8/22/2023, I spoke with Diane Zagorski in your office and explained everything that I have explained here. At that time, she told me that I had done everything that I could have done but asked if I had emailed an image of the return donation. I had not done this because there was never any instruction to do this. She also told me that our fines were over \$300 at that point, but that she would put a note in the system to stop additional fines. She also provided me the link to this form so that we could explain the situation and request a release from the fines. We did everything that was available to us via the MDCRIS website. In fact, the option we chose was consistent with the instruction on the Deficiency Report which states "On the next campaign finance report due, indicate the return of the contribution on Schedule 2: Z-Returned Contribution." This is exactly what we did and we did it on time; therefore we should not face any late fines. Thank you for your consideration of this request and explanation.

The Board should consider the following factors in determining whether just cause exists to grant a waiver.

- 1. Administrative error of any kind on the part of the Division.
- 2. The lateness is due to extenuating circumstances, i.e. physical illness or death in the family; or
- 3. Computer problems occurred which made timely filing impossible. However, the filer still must have demonstrated a good faith effort to timely file.

Prior to the meeting please review each waiver request. Note the recommendations that you may disagree with or have questions on that you would like to discuss.

§ 14-107(c) Late Filing Fees

- (1) As provided in this subsection, the State Board may impose fees for late filing of:
 - (i) a statement required under § 14–104 of this title; or

Good afternoon,

I am reaching out on behalf of a constituency group in our district, AnnDyl Policy Group. While attempting to submit their campaign contribution disclosure, the website was allegedly having technical difficulties. As a result, they were unable to file on time and received a fine. Below is some of the information they relayed to me:

AnnDyl made every effort to file on time (before the due date of November 30, 2022) but had been unable to do so because of online system-related issues. Specifically, the online system prevented us from accurately populating information for the filing. AnnDyl had reached out to the State Board of Elections multiple times via multiple emails and phone calls to rectify this issue which was finally done early December. We then received two late notices and a fine letter for lack of timely submission. We filed a waiver to have these fines lifted due to the state's technical issues for the first time filing and were denied. When I was having much trouble on November 29th last year figuring out this new system I reached out (these emails were after many calls and voicemails) and you can see that they had to back date our registration due to the system not recognizing us since our registration was done November 2nd, and the disclosure period ended on October 31st.
