## Request a mail-in ballot

Any registered voter can use this form to request a mail-in ballot for Maryland elections.

### Request online



Save time and request a ballot online at [vote.md.gov/NeedBallot](https://vote.md.gov/NeedBallot). You will need a MD driver's license or MVA-issued ID card to use the online form.

### How do I return this form?

Return your completed signed form to your local board of elections. You can return it by **mail**, fax, email. You can also drop it off in person.

Find your local board of elections address at [vote.md.gov/LBElst](https://vote.md.gov/LBElst).

Make sure to return this form by the correct deadline listed below.

### How will I receive my ballot?

The primary way to receive your ballot is by **mail**.

We can mail your ballot to any address you want. You will also receive a return envelope with prepaid postage.

You also have other options. We can email you a link so you can **print your ballot**, we can fax your ballot, or you can pick it up in person.

If you choose to pick up your ballot in person, go to your local election office about 45 days before an election. If you want somebody to pick up your ballot for you, you must provide a Designation of Agent form. Find this form at [vote.md.gov/MDagent](https://vote.md.gov/MDagent).

### When will I receive my ballot?

After you submit this form, we will send your ballot about **30-45 days before the election**.

## Deadlines to return this form

Your deadline depends on how you return this form and on how you want to receive your ballot. If you mail or hand deliver your request, your form **must be in the office** before the deadline. Postmarks don't count.

**To receive your ballot by mail or fax, you must submit this form by Tuesday, June 16, 2026**

Returning by mail or hand delivery? Submit by 8pm.

Returning by email or fax? Submit by 11:59pm.

**To print your ballot from an emailed link, You must submit this form by Friday, June 19, 2026**

Returning by mail or hand delivery? Submit by 5pm.

Returning by email or fax? Submit by 11:59pm.

### General Election

**To receive your ballot by mail or fax, you must submit this form by Tuesday, October 27, 2026**

Returning by mail or hand delivery? Submit by 8pm.

Returning by email or fax? Submit by 11:59pm.

**To print your ballot from an emailed link, You must submit this form by Friday, October 30, 2026**

Returning by mail or hand delivery? Submit by 5pm.

Returning by email or fax? Submit by 11:59pm.
